You are hereby notified that the Milwaukee Common Council will hold a hearing on Tuesday, June 3, 2025, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider the renewal with a 20 (twenty) day suspension of your Class B Tavern, Public Entertainment Premises and Food Dealer licenses for the premises located at 1209-13 N Water St. ("Brothers Bar & Grill").

Attached you will find a copy of the Report of the Licenses Committee, which includes its Findings of Fact, Conclusions of Law, and Recommendation, recommending renewal with a 20 (twenty) day suspension of your Class B Tavern, Public Entertainment Premises and Food Dealer licenses based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to the health, safety or welfare of the public for the assaults, battery and disturbance of the peace.
