Dear Mr. Amir:


We have received your claim in the amount of \$1,644.33, relating to damage allegedly sustained to your vehicle on when it collided with a pothole along the roadways near your home. You did not indicate a specific location or loss date.

The Infrastructure Services Division reviewed their records and the Department of Public Works Call Center records for the year proceeding the filing of your claim on October 26, 2007 for the area along West Concordia Avenue, between North 91<sup>st</sup> Street and North 92<sup>nd</sup> Street; West Auer Avenue between North 91<sup>st</sup> Street and North 92<sup>nd</sup> Street; North 90<sup>th</sup> Street between West Auer Avenue and West Burleigh Street and North 91<sup>st</sup> Street between West Concordia Avenue and West Burleigh Street. They found prior to October 26, 2007 the City had no notice of any specific hazard in these roadways and because of this lack of notice, the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
