**W. Florist Ave. (Excluding Structure) – N. Lovers Lane Rd. to N. 119th St. (ST211060131):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (9-foot width of tree border area), and grading.

**N. 91st St. – W. Burleigh St. to W. Keefe Ave. (ST211080105):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (9-foot width of tree border area), and grading.

**5th and 10th Aldermanic Districts**

**W. Hadley St. – N. 74th St. to N. 76th St. (ST211070119):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, (7-foot width of tree border area), and grading.

**13th and 14th Aldermanic Districts**

**S. Howell Ave. – E./W. Howard Ave. to E. Wilbur Ave. and S. Chase Ave. – S. Howell Ave. to E. Ohio Ave. (ST320060801):**

Concrete pavement reconstruction, replace all curb and gutter and driveway approaches, replace sidewalk and tree removal where necessary, sodding (17-foot to 22-foot width of tree border area), and streetscape.
