Dear Mr. Green:

This office is in receipt of your claim in the amount of \$501.39, relating to damage sustained to your vehicle January 9, 2003 when it collided with a police vehicle at North 6th Street and West Wisconsin Avenue.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report completed as a result of this accident notes that the marked police vehicle had concluded a traffic stop and began to slowly back up with its warning lights activated. You made a left turn across the path of the police vehicle, came to a stop behind it and then began to pull ahead as you were hit. We have evaluated the liability to be 50 percent on each vehicle. The police vehicle has no damage to claim. Pursuant to the March 19, 2003 conversation you had with our office, the City of Milwaukee is prepared to off you \$250.70, which is 50 percent of your damages. As such, the City of Milwaukee proposes to settle this claim for \$250.70.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
