[Handwritten initials] We have received your claim in the amount of \$1,217.56, from a loss on February 4, 2020 when the Milwaukee Police Department (MPD) was involved in a search for a suspect and your car was damaged.

The MPD indicates that an officer had been shot. They were searching for the suspect. The MPD located the suspect in the garage under your car. The suspect then shot himself. The officers jumped onto the car for cover. There is no evidence that the MPD was negligent. The City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

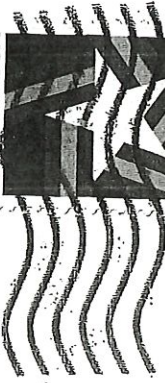
