
Dear Mr. Loffredo:


We have received your claim in the amount of \$1,421.40, relating to damage sustained to your vehicle on October 22, 2007 at North 6th Street and West State Street when a vehicle that was being pursued by the Milwaukee Police Department (MPD) struck a light pole, which then fell on your car.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report completed for this incident noted the vehicle was fleeing from the MPD. The primary liability for this accident rests with the individual that was fleeing from the police, as such, the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
