

While we regret that the Kaszubas had a sewer backup, we must respectfully deny your subrogation claim. per inspection, ins'd pointed out the larger dollar items in basement that were damaged. They are in middle of remodeling first floor of 1 story home. Mr. ins'd is a contractor so doing remodeling himself. Many items in basement at the time of loss; however, large percentage of items were off the floor stacked up or on shelves. I was expecting a contents loss for \$5k or so. they submitted a loss around \$25,000. this is inconsistent with normally basement stored items/ financial status, etc... It is winter, why are many winter clothes in basement? Newly purchased items (not only recently purchased, but why are they in basement?) new DVD player and DVD video stored in basement when TV is upstairs and why is new equipment stored on the floor?

Ins'd pushing to have foundation and landscaping cov'd.

also indicating that garage concrete floor was cracked and damaged due to loss from sewage going under foundation and heaving and raising floor. (If cold enough to freeze, how could it go through the frozen ground and then freeze and expand? doesn't make sense.

Contents claimed not consistent with lifestyle, value of home, size of basement, amount of items that would actually fit on floor vs. off the ground, winter season items claimed to be stored in basement...on floor, recently purchased the majority in the past year (who stores their new stuff in the basement and on the floor? it would be common practice to use new purchases and store the old).

Mr. K will e-mail digital pictures to me. He described the sewer line bursting and water/sewage bubbling up in the middle of the street, then bubbling up from a hole in his yard at the southeast corner of the house, about 12' from the house, and then another hole right at the S/E corner of the house. The sewage then ran down the slight slope to the back of his property, flooding the detached garage, freezing and now causing the service door to heave up already. Electricity is run to the garage so he has a heater out there.

The police were cruising by at about 3:30am, and saw water and sludge flooding the neighbors' yard and the Kaszuba's yard, and coming into the Kaszuba's house and garage. They knocked on the door and woke the customers up. Mr. K. is a construction worker, so he immediately started working to clear out the 6-7" of water in the basement -- the City of St. Francis helped pump the water out of the basement where it had seeped in and run in the basement windows, and gave them salt to spread on the water/sewage on the floor of the garage which has already frozen because it is about negative 25 degrees there with the wind chill right now.

A City of Milwaukee water/sewage pipe broke in the yard between the neighbors' and csts' house. The customers' house is slightly below grade of the neighbors, so most of the sewage and water has flooded their yard, and also started affecting the road in front of the house. The neighbors' yard is flooded also, but she doesn't think sewage/water entered their house.

Customers have been remodeling their house, and moved much their furniture and belongings to the unfinished basement, along with new cabinetry that they were going to install. These items have all been affected by the water/raw sewage.

Since Mr. Kaszuba is a construction worker, he wants to do his own clean-up, and they are using their dehumidifier, 2 heaters, and house fans. He will want to do his own repairs as well. I explained that we would recommend a professional cleaner/mitigation company to deal with this, but they have pretty well decided that they want to do this work themselves.

I discussed loss w/mgr Bob Lombardo, and we are covering this loss since there was an accidental leak of water from a pipe, not a natural occurrence, and the water is coming from an immediate source (not a source down the street, when there would be a question of whether it is really "surface water" at that point). This appears to be a large loss, so I recommend field assignment.
