On September 25, 2007, at 3:07PM the Milwaukee Police Department was called to 2925 W. Burleigh Street for a suspect in a murder investigation, who force his way into a home and held 2 children and 2 adults' hostage.

The Police surrounded the home and shot were fired from the inside of the home by the suspect around 3:15PM. Please note that they were no further activity coming form the home after that initial shooting until around 7:20PM when the MPD tactical unit started to shoot tear gas into the home.

Tear gas was shot into the home from all directions and through all floors including the basement. A total of 24 windows were destroyed out of a total 26 by the MPD tactical unit. These windows were new windows that were installed in May of 2006. Not only was the windows destroyed, but the siding and window frames were damage from the shots that were fired by the tactical unit.

The carpet and other porous material had to be removed and thrown away; drywall where tear gas penetrated the walls also have to be replaced. The entire house has to be repainted and a hazardous material cleaning company had to come in to clear the tear gas out of the home.

The tenants were homeless as a result of this incident and were unable to use any of their belongings except for their clothing. My tenants ere innocent victims in this unfortunate situation, and had nothing to do with this event that took place.

I am inclosing a copy of my claim that was process by my insurance company adjuster. The highlighted areas is what I am requesting reimbursement. MY deductable of \$500.00, loss of a refrigerator and stove in the upper unit \$520.00, and other losses or depreciation which total \$1682.12 and finally loss of rent of \$4400.00 for four months.
