
Dear Mr. Maloney and Ms. Petersen:

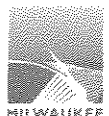
