The Board may receive a motion to convene in closed session in City Hall, room 301-B, 200 East Wells Street, on the promotions or probation extension request in the Police Department or the promotions in the Fire Department pursuant to Section 19.85 (1)(c) Wis. Stats. to consider employment, promotion, compensation or performance evaluation data of any public employee over whom the Board has jurisdiction or exercises responsibility, to wit: promotion to Inspector of Police, Police Captains, Community Service Officers, Deputy Chief, Fire and Battalion Chief, Fire, pursuant to Section 19.85 (1)(f) Wis. Stats. to consider financial, medical, social or personal histories of specific candidates for employment which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories, if necessary. The Board may then reconvene in open session concerning any such item following the closed session.
