4. On 11/19/14, applicant was cited for Building Code Violations at 1917 W Mitchell Street.

5. On 05/06/15 at 1:35 am, Milwaukee police responded to 6541 S 13th Street for a Theft of Vehicle complaint. Investigation revealed a customer picked up a prostitute in the area of 12th and Greenfield and brought her back to his room. He went into the bathroom and when he did, heard the door to his room close and when he went out to the room, found his pants and noticed that his keys to his car were gone, as well as his wallet and cash. Officers spoke with the clerk on duty and asked to view surveillance video, but the clerk did not know how to operate the system. Police returned on 05/06/15 and were able to view the surveillance tape. No cameras were where the vehicle was parked.
6. On 06/05/2015 at 10:32am officers responded to Econo Lodge, 6541 S. 13th St, for a subject with a gun. The investigation revealed a domestic violence incident where the ex-boyfriend was knocking on the door yelling to open the door or he would kill everyone in the room. No gun was observed and the subject was located walking away. The subject stated he did not have a gun, he just came to get his stuff. The subject was arrested.
7. On 08/18/2015 a possible sexual assault occurred at the Econo Lodge, 6541 S. 13th St. The victim reported going to the room with the suspect and waking up alone with her pants off. Officers went to the Econo Lodge to check for a crime scene related to a sexual assault in room #241. The officers arrived and found the room was already cleaned.
8. On 09/07/2015 at 1:52pm officers responded to Econo Lodge, 6541 S. 13th St, for a Sudden Death investigation. When the officers arrived they found MFD Engine #14 on scene in room #143 with the deceased, Christopher GARRISON. The investigation revealed GARRISON had a life-long drug addiction and heroin was found in the room. The witness stated for several days he heard people knocking on the window to room #143 and thought GARRISON was selling heroin.
9. On 11/08/15 at 4:20 pm, responded to a RES complaint at 6541 S 13th Street. The victim stated that someone had shot a bullet hole into his hotel room and that management refused to call police. The victim came to District 6 to file a complaint. The victim stated he was living at the Econo Lodge with his family for one month and had been living in another hotel because of threats to his family from a tenant he had to move from that location. The victim stated at 6 am, he woke up and walked into the bathroom to wash up and noticed a large hole through the bathroom mirror and another hole in the side wall. Glass from the mirror had been shattered in the sink and on the floor. The victim believed a bullet had been fired into his room, though he, nor his family, heard the noise. The victim further stated he called the front desk, Pam SINGH, to notify her of what he found and requested she come to his room to inspect what happened. SINGH stated she had a lot of things to do at the time, but would see him later. Ms. SINGH came to the room about 7 am and observed the damage, stating to the victim the damage was minor and that she would have someone come to clean it up. The victim requested that the police be called because he believed it was related to the prior threats to his family from the other hotel. Ms. SINGH refused. The victim stated that the hotel security guard Leslie JOHNS, also came to his room and also inspected the damage, as well as the adjoining room of where the damage occurred. The victim took pictures the damage from the adjoining room when the

security guard grabbed the victims phone stating he could not take pictures of the damage and deleted the pictures that were taken. The owner of the hotel, Sanjay PATEL, was called by the security guard who advised him of what occurred. PATEL then spoke with the victim who told PATEL that he wanted police called regarding this matter. PATEL then stated to the victim that if police were called, PATEL would evict him and his family. At approximately 12:00 pm, the victim stated he noticed hotel staff cleaning the adjoining room from where the bullet came from. At 1:35 pm, hotel staff knocked on his room door stating they were there to clean up the damage in the bathroom and that if he didn't let them in, he was going to be evicted. The victim later advised police that he had recorded the conversation with Ms. SINGH refusing to call police. Police later spoke with Ms. SINGH who denied saying she refused to call police and was doing just what the security guard told her to do. Police also spoke with the owner, Sanjay PATEL, who came to the scene. PATEL denied refusing to call for police and stated that no one advised him about bullet holes in any rooms. PATEL further stated that the security guard told him that a mirror had been broken. Supervisors were called to the scene and Ms. SINGH was arrested for Obstructing an Investigation, cited and later released from the station. The security guard was also cited for Obstructing. The owner, Sanjay PATEL, was cited for Chronic Nuisance Premise. An investigative alert was filed for the possible known suspect. Case Pending.

10. On 11/09/15 at 9:52 pm, Milwaukee police were dispatched to 6541 S 13th Street for a Soliciting complaint. Police spoke with security officer for the hotel Leslie JOHNS who stated the renter of room #142 may be involved in soliciting because there have been men going in and out of their room all day. Police spoke with the subject in room #142 and identified her as Terry Ann CARRILLO. A wanted check was done and the subject was found to have warrants for her arrest that included Loitering/Soliciting. Another subject in the room was identified as Laquinta YOUNG, also had an outstanding warrant. Both subjects were arrested and advised to not return to the property.
11. On 03/10/2016 a meeting was held at District 6 regarding Econo Lodge, 6541 S 13th St. The applicant was at the meeting with his attorney, Vincent BOBOT. Also at the meeting were ACA Nick DeSIATO and Captain Diana ROWE. The applicant gave plans for improving the property which included posting No Loitering signs, installing new cameras, repairing and installing new exterior lighting, repairing the exterior doors to lock from the outside and hiring security. The applicant was advised to have employees monitor the halls for people gathering and soliciting. On 04/09/2016 an officer went to conduct follow up on the presented plan. The officer found signs by several doors but no sign by door #3. There were several exterior lights

not working and the cameras appeared to be three different styles, some seemed to be older models. Two of the cameras were facing the ground or at a low angle. The officer found the exterior doors locked but could be opened if pulled hard. Door #3 was not locked at all. There was a SPI car driving through the parking lot. The security guard stated he patrolled several businesses in the area from 7pm to 2am. The front desk is keeping track of vehicle license plates of short term renters and one long term tenant.

12. On 03/15/2016 at 5:20pm officers were dispatched to Econo Lodge at 6541 S. 13th St for a trouble with subject. The caller was a resident of the hotel and observed a male and female shooting heroin while seated in a van in the rear parking lot. A check of the registration revealed the van was listed to Best Medical Transport. The owner of the van provided the name of the employee, Tracy CLAYTON. Her room number was located in the hotel and she admitted to police that she and her husband, Kurt CLAYTON, had smoked "crack" and injected heroin in the vehicle. CLAYTON and her husband were cited for Possession of Drug Paraphernalia.

13. On 04/21/2016 officer responded to Econo Lodge, 6541 S 13th St, for a trouble with subject call. The caller was SPI Security guard Thomas JAHNKE. He stated he was told by the clerk to check a room for subjects smoking "crack". He went in the room and found a crack pipe so he called police. JAHNKE took the officers to the room. The officer observed an ashtray with a decorative golf club but no crack pipe. JAHNKE was asked where the crack pipe was and he pointed to the decorative golf club. He was advised it was part of the ashtray and not a crack pipe. The applicant was not on scene and the only number for him is the hotel number.

14. On 09/24/16 at 10:18 pm, Milwaukee police were dispatched to 6541 S 13th Street for a battery complaint. Investigation revealed occupants in the hotel had gotten into an argument. Both subjects were intoxicated and issued disorderly conduct citations. The licensee, Sanjay Patel, was advised of the incident and Patel advised the male subject that he was no longer allowed on the property.

15. On 05/24/19 at 6:30pm, Milwaukee Police were dispatched to 6541 S. 13th Street for a theft complaint. Officers interviewed the caller who stated that a maintenance worker entered her room without knocking, so she went to complaint to the front desk. When she returned, she noticed that there was money missing from her purse. The caller then went to the front desk, told the clerk what happen, and the clerk gave the caller some money. Officers interviewed the front desk clerk who stated that the caller did complaint to her about the maintenance worker (whom she talked to and he stated that he did knock on the door) and she did refund her some money because the caller was yelling and screaming, so she wanted to avoid a disturbance. The clerk also talked with neighboring rooms who confirmed that the maintenance worker did knock on the callers' door. A report was filed.

16. On 07/13/19 at 1:19am, Milwaukee Police were dispatched to 6541 S. 13th Street for a fight complaint. Upon arrival, officer's observed 20 subjects in the lobby upset and arguing with the desk clerk but no active physical fight. The subject in the lobby were complaining that there rooms had bed bugs and wanted a refund, but the front desk clerk refused to give refunds. The clerk was asked to call the manager to see if he could approve refunds to the customers. The manager approved the refund distribution and the clerk gave refunds to the subjects.

This report is being written by P.O. Christopher JACKSON, assigned to District Six, Late Power Shift.

On Friday, May 24, 2019 I was assigned to Squad 6468, the License Premise Unit. At approximately 7:25pm I took over a call for service that was originally dispatched to Squad 6250, Ahnoki DOXTATOR. The call for service was regarding a theft that took place at the Econolodge located at 6541 S. 13th St. in the City of Milwaukee.

While at the District station I contacted the caller by phone due to her being at a different location. I made contact with Gina L. STALLINGS (F/B 02-06-82) that stated she wanted to file a report for stolen money taken from her purse. STALLINGS stated that she checked into the hotel at 12:00am on today's date and had the room reserved for two nights. She stated that between the time frames of 4:30pm and 5:30pm today she was in her rented room 254. At which time an unknown male subject who she describes as a Hispanic male, 40's - 50's, clean shaven, wearing glasses, gray baseball cap, econolodge gray shirt and army fatigue pants walked in on her. STALLINGS stated that she was naked in the room and the subject just stopped and starred at her until she yelled for him to leave. She stated that she dressed herself and went to confront the subject. She later realized it was an employee of the hotel and she expressed to him her frustration of him entering the room without knocking. STALLINGS then stated that she went to the front desk to attempt to make a complaint to the supervisor. When she got to the front desk there was no one there to speak to. As she was returning to her room she observed the lady that was seating at the front desk walking away from the area of her room and flagged her down. It was later identified that she spoke with Mandeep K. BHULLAR (F/W 10-05-92). BHULLAR told STALLINGS that she would talk with the male employee regarding the incident. STALLINGS then stated that she returned to her room and it looked as if her purse that she had sitting on the night stand had been moved. She checked her purse and stated that she was missing a total of \$210 dollars in US currency. STALLINGS went back to the front desk and informed BHULLAR of her missing money and demanded a refund do to the incidents. STALLINGS stated that she received \$185 back and left the hotel. When STALLINGS made it to the new hotel she then called police because BHULLAR did not seem concerned about her complaint of the theft.

I went to the hotel and spoke with BHULLAR that stated she spoke with STALLINGS regarding the employee entry. BHULLAR stated that STALLINGS was yelling at her regarding the house keeper named Shaminder. BHULLAR stated that she spoke with Shaminder that told her that he knocked on the door 2 or 3 times and did not get an answer. She stated it is normal procedure that the employee would knock first and if there is no response nor do not disturb door hanger then they are allowed to enter to replace towels which he was there to do. She also stated she spoke with several neighboring guest room that confirmed that he has been knocking on the doors before entering. BHULLAR believes the incident took place at approximately 6:00pm. She stated that STALLINGS was yelling and screaming she wanted her money and didn't want her causing a disturbance so she paid her money back.

LICENSE PREMISE REPORT

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late power Shift.

On Saturday, July 13, 2019 I was assigned to the License Premise Unit, Squad 6468. I was also working in normal Milwaukee Police uniform affixed with an Axon body camera.

At approximately 1:29am I responded to a Fight call for service at the Econo Lodge Hotel 6541 S. 13th St. in the City and County of Milwaukee. The cad call #191940185 stated that over 10 people were in the lobby of the location complaining of bed bugs and the clerk refusing to refund money. While in route to the location the call was updated stating that the subjects were now physically fighting.

I arrived to the location with squad lights and siren activated and entered the lobby. There were approximately 20 subjects in the lobby standing and sitting around upset and arguing with the desk clerk. There was no physical fight observed among anyone at the location. I briefly spoke with several subjects in the lobby that all had the same concern and argument of having bed bugs in their rooms. Everyone wanted a refund and stated the clerk would not give them one without his manager's approval and refused to give them information for the manager.

After calming down the crowd of upset customers, I spoke with the front desk clerk Peter R. WARGOLET (M/W 10-24-60). WARGOLET and I spoke in a back room regarding the issue. WARGOLET informed me that one lady came down to the desk stating that she had bed bugs in her room crawling on her bed. She showed him a video of the bug itself in the room. He stated that he and lady were going back and forth about whether he would refund her the money, check her into a different room or give her a discounted price. The lady demanded a refund and caused a disturbance yelling about the bed bugs to new guests coming in. WARGOLET then issued the refund for the night. The female had left the location before my arrival.

I then requested that WARGOLET contact his manager regarding the issue. WARGOLET contacted his manager Sam PATEL and was approved to issue refunds to all guests in the lobby. As he issued refunds, I then began to speak more with the guest and collect information.

I spoke with Giselle ROSALES (FW 02-14-99) who stated that when she was checking in there was a female in the lobby complaining about bed bugs. She still checked in and was assigned and given key cards for room #113. While in room #113 she examined the bed and was able to observe several bed bugs crawling. She later received a refund and left the hotel.

I spoke then spoke with Ashley M. PEREYDA (F/W 12-05-97) who stated that she checked into room #232. She also had rooms #226 and #227 checked in under her name. When she got to room #232 she checked her bed and observed several bed bugs near the corner of the mattress underneath. She later received a refund and left the hotel.

I then spoke with Stephanie T. CARTER (F/B 03-09-61) who stated that she was part of a wedding party that all checked into the hotel. They had already spent one night at the hotel but some of them began complaining of itching. Another subject from their party checked their bed and located bed bugs. The subject then recorded it for evidence to show the clerk and sent it to the rest of the party. CARTER did allow me to view the video on her phone showing the bug on the mattress. 
