This office is in receipt of your claim in the amount of \$4,950.00, relating to your vehicle being towed and eventually scrapped after being reported stolen on December 6, 2002 while parked at 3334 North Teutonia Avenue.

Our investigation reveals that the Department of Neighborhood Services records indicate that on November 14, 2002 they wrote an order and placarded your vehicle as a nuisance vehicle at 3334 North Teutonia Avenue. The order was mailed on November 18, 2002 to Milton Davis, the listed owner of the property, at his last known address of 2721 West Concordia Avenue. A Warning Notice was mailed to you on that day, as the listed owner of the vehicle, informing you of the impending removal of your vehicle. This was sent to 202 East Keefe Avenue, Milwaukee, WI 53212, the address indicated by the Department of Transportation. A re-inspection on December 2, 2002 revealed no change in the condition of the vehicle and no contact from either the property owner or you. The vehicle was subsequently towed on December 11, 2002. The department acted appropriately in this matter and as such, the City would not be liable. Accordingly, we are denying your claim.
