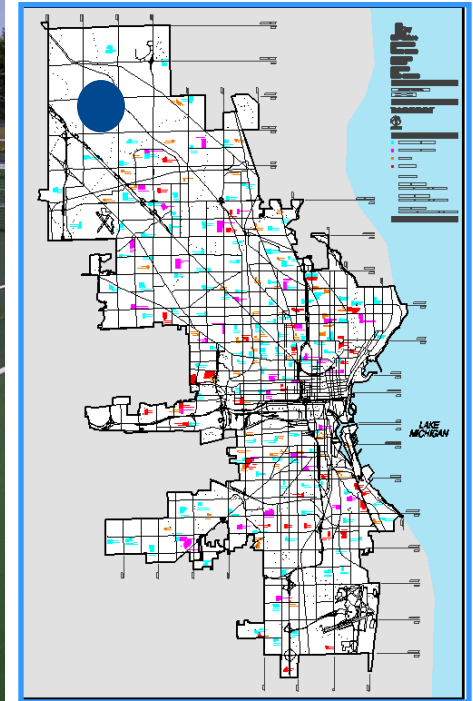

Eight tennis courts, which were overrun with cracks, were reconstructed.



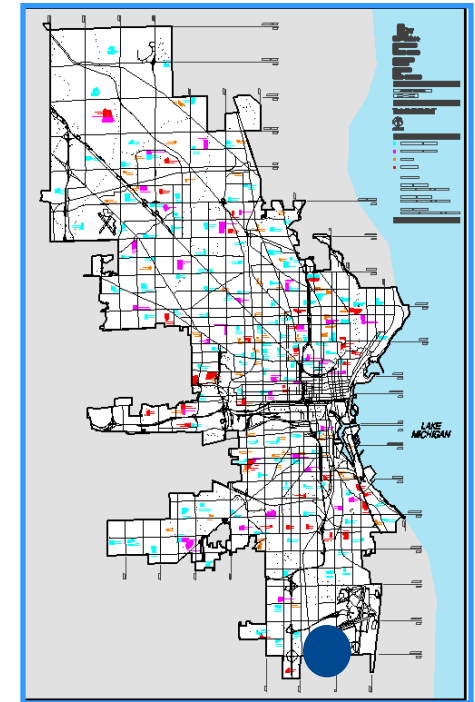

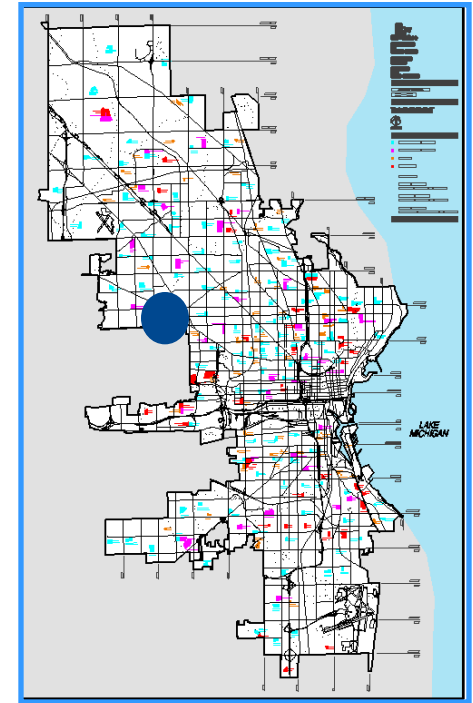

The reconstruction included more green areas, play opportunity with additional swings and a jogging path. A reconstructed path allows easier access to the site.

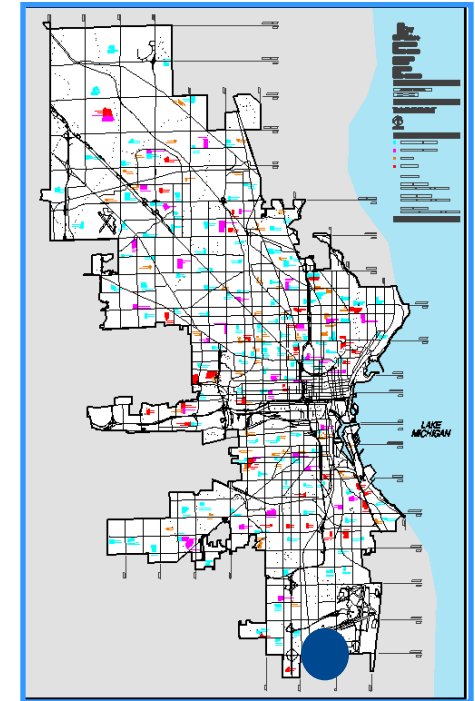
In conjunction with the playfield reconstruction, the comfort station was also made accessible. This project was completed with input and contributions from the Enderis Playfield Association

13th Alderman District

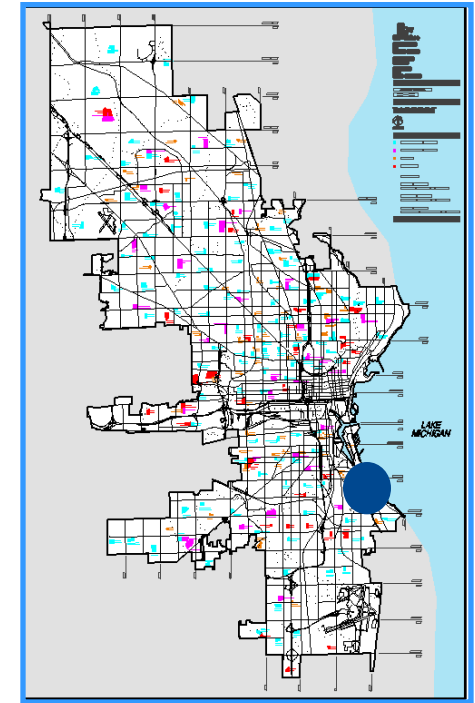
Phase two of playlot reconstruction will include an accessible path and minor repair work including color coating of the existing tennis court and basketball court.

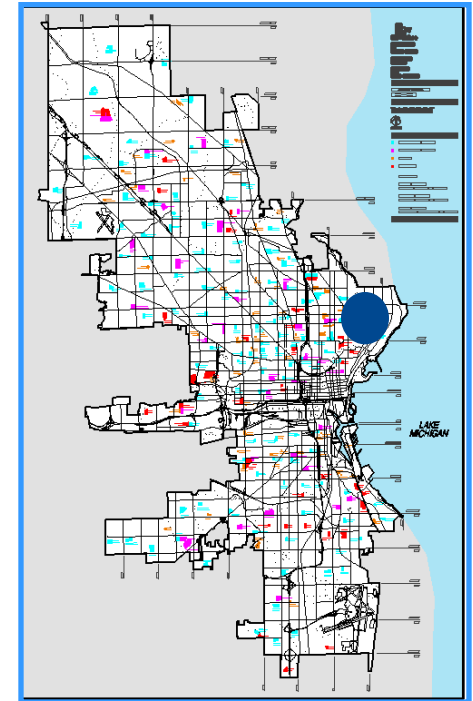

The tennis courts will be reconstructed in order to better compliment the newly constructed adjacent Urban Ecology Center.

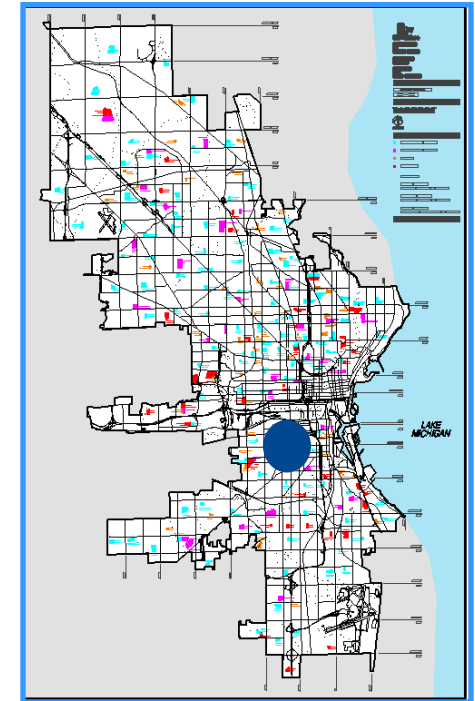

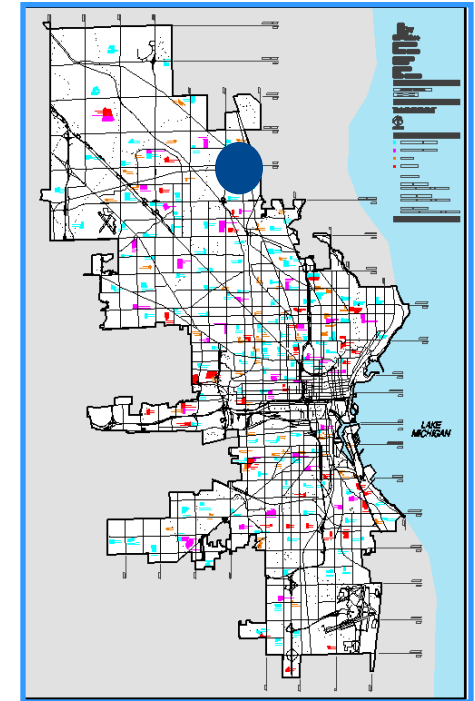
Obsolete play equipment will be replaced with a new play structure, benches and surfacing, which will provide better safety and accessibility.

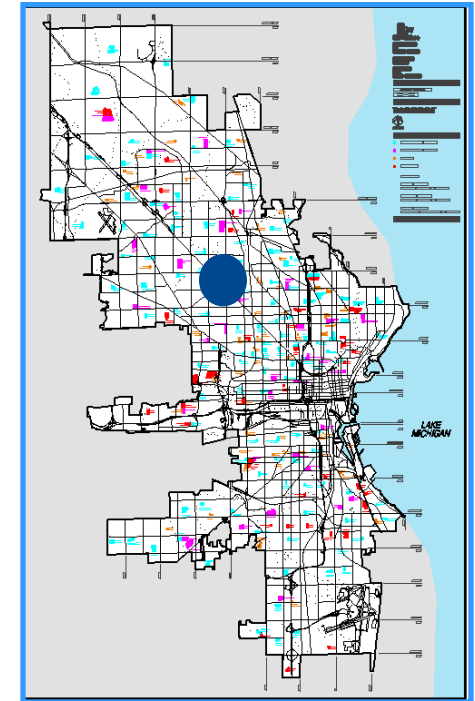

A path, resilient surface and transfer deck will make the site and equipment more accessible.

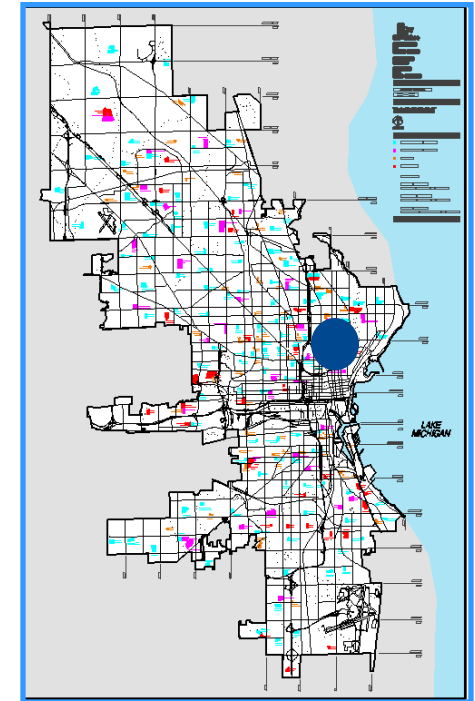
