This report is written by P.O. Timothy PTASZEK, Assigned to District One, Early Shift. On 02-06-15 at 6:29 PM while on patrol assigned to squad 1261 in the 600 block of W. Wisconsin Av. I observed a B/M later identifed as Jermaine M. TYLER, B/M 08-29-74, inside the Avenue Liquor at 616 W. Wisconsin Av. I observed TYLER at the cash register inside the store pay for an item. The item was placed into a paper bag, and as TYLER began to walk towards the exit door, he opened the item which was identified as a 16oz. Milwaukee's Best beer. TYLER was still inside the store when he opened the beer, Tyler exited the store and began to drink from the beer on the public sidewalk right in front of the entrance to the liquor store. As TYLER observed my partner, P.O. CRIVELLO, and I walking up to him he attempted to hide the beer. TYLER stated he had just purchased a single can of beer from Avenue Liquor, and just wanted to drink the beer. TYLER was cited for public drinking and released from the scene.

While on scene I went and spoke with the cashier of Avenue Liquor, Jasbir Singh Sherbill, I/M 09-04-62, who lives at 610 W. Wisconsin Av. The cashier stated he observed TYLER purchase the beer and didn't know TYLER opened the beer in the store.

- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
