



- 3. Pursuant to Chapter 90 of the <u>Milwaukee Code of Ordinances</u> and Chapter 125 of the <u>Wisconsin Statutes</u>, the matter was referred to the Milwaukee Police Department for investigation. On July 10, 2002, the Milwaukee Police Department responded with a police report that created a basis for non-renewal or suspension of said license.
- 4. On July 11, 2002, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. - 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

Macinac Avenue #2, Milwaukee, Wisconsin, 53172, in an envelope bearing the return address of the License Division by United States First Class, prepaid mail. The envelope bearing the Notice of Hearing was not returned to the License Office by the United States Postal Service and the licensee did not appear. The envelope was addressed to the address provided by the applicant on her application.

## CONCLUSIONS OF LAW

Report on the Renewal Application of the Class "B" Tavern License of Douglas J. Mitchell for the premises located at 3246 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Joru's").

- 1. Douglas J. Mitchell (hereinafter "the Licensee") is the holder of a Class "B" Tavern License for the premises located at 3246 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Joru's"). Said license expires at midnight on August 1, 2002.
- 2. An application to renew said license was filed with the Office of the City Clerk on June 27, 2002.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 28, 2002, the Milwaukee Police Department responded with a report that could form the basis for suspension or non-renewal of said license. In addition, there were neighborhood objections to renewal of this license based on loud and noisy patrons exiting the tavern, firearm activity, and conduct detrimental to the health, safety and welfare of the neighborhood.
- 4. On July 11, 2002, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department Report and the neighborhood objections to renewal of this license and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report and the neighborhood objections on July 23, 2002, commencing at 9:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee failed to appear at the hearing.
- 5. Based upon the testimony heard and evidence received, the Committee finds as follows:
  - A. Notice of the hearing of the Milwaukee Police Department report and neighborhood objections were sent to Douglas J. Mitchell at 2851 North 37<sup>th</sup> Street on July 11, 2002 by United States first class, pre-paid mail in an envelope bearing the return address of the License Division. It was addressed to the address provided by the licensee on the application. The licensee failed to appear at the hearing.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Douglas J. Mitchell has not met the criteria to allow renewal of his Class "B" Tavern license based upon non-appearance.

## RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern License of Douglas J. Mitchell for the premises located at 3246 North Teutonia Avenue ("Joru's") in the City and County of Milwaukee, Wisconsin not be renewed.

Report on the Renewal Application of the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) License of Marlon K. Teague for the premises located at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club").

- 1. Marlon K. Teague (hereinafter "the Licensee") is the holder of a the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) License for the premises located at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"). Said license expires at midnight on July 28, 2002.
- 2. An untimely application to renew said license was filed with the Office of the City Clerk on June 18, 2002.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On June 20, 2002, the Milwaukee Police Department responded with a report that could form the basis for suspension or non-renewal of said license. In addition, there were neighborhood objections to renewal of this license based on a patron being shot, disorderly conduct by patrons of the bar, patrons fighting, battery, loud and noisy patrons exiting the tavern, loitering, littering, and conduct detrimental to the health, safety and welfare of the neighborhood.
- 4. On July 11, 2002, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department Report and the neighborhood objections to renewal of this license and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report and the neighborhood objections on July 23, 2002, commencing at 10:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The licensee was represented by Attorney Michael A. I. Whitcomb, 633 West Wisconsin Avenue, Suite 510, Milwaukee, Wisconsin 53203.
- 5. Based upon the testimony heard and evidence received, the Committee finds as follows:
  - A. On September 17, 2001 at 1:26 a.m., a patron left the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium

- Club") after an altercation with another customer in the bar. Upon leaving he was subsequently shot multiple times by a suspect who was also in the bar.
- B. On November 5, 2001 at 1:45 a.m., a patron was involved in an altercation inside of the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"). After being put out by security, the patron was punched in the face, causing a fractured jaw, broken teeth and a laceration to her lip requiring stitches to close.
- C. On November 22, 2001 at 1:57 a.m., officers were dispatched to licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club") for crowd control. On arrival, officers observed a very large crowd in front of the New Millennium Club. While officers attempted to move the crowd, two people in the crowd became disorderly with officers. They were arrested and issued citations for disorderly conduct.
- D. On May 25, 2002, officers investigated a verbal confrontation between patrons, which started inside of the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"), and which escalated to a fight. Once outside the club, a victim received a minor cut to the rear of his head. Medical treatment was refused.
- E. On December 11, 2001 at 1:20 a.m., officers were dispatched to a battery complaint at Mt. Sinai Hospital, 945 North 12<sup>th</sup> Street. Their investigation revealed that a patron at the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"), was dancing when an unknown person hit her on the right side of the forehead with a bottle. Twelve stitches were required to close the cut. Subsequently, it was learned that two additional victims required medical treatment for lacerations, which they sustained while inside the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"). The personnel of the licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club") never called for the police to respond to a fight.
- F. On December 22, 2001 at 1:08 a.m., officers were dispatched to licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club") for a fight. Upon arrival, the officers spoke to the licensee, who was at the front door. He told the officers that as he was at the front door, he did not see what occurred. The officers spoke to the bouncer who told them an argument had broken out between two men, but that he and the other bouncers had taken care of the situation. They escorted the man out who started the problem; and when they did that the friends of the person being escorted out, started throwing things at the bar. The bouncer stated they could not handle the crowd but they decided not to call the police. The licensee, Marlon Teague was cited for disorderly premises and found guilty and

- fined \$364.00 on May 12, 2002. Counsel advised the committee this matter was reopened on July 15, 2002 and is set for further proceedings on September 16, 2002.
- G. On May 11, 2002, officers responded to backup for another squad regarding a large fight. On arrival they observed several subjects fighting outside the New Millennium Club, 518 North Water Street. They approached one of the persons involved in the fight and he was placed under arrest due to his involvement. He became aggressive toward the officers. He was handcuffed. He told the officers he came to the club with his brother to collect some money that the club owner owed him for not reporting a fight to police that occurred the previous week. He said that after leaving the club he was approached by a group of men whom started arguing and the fight started. The officers spoke to the licensee, who stated that he had no knowledge of a payoff regarding a fight that took place inside the club a week ago.
- H. On February 4, 2002, officers conducted a tavern check at licensed premises at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club"). Officers checked the license which was valid with a capacity of (100 persons). Officers conducted a brief headcount and estimated the number of patrons to be about 140. Officers then contacted the licensee Marlon K. Teague and advised him they were going to conduct a head count to determine the actual number of persons present in the tavern. Head count revealed there were 165 persons present in the tavern. Mr. Teague was then cited for over capacity of posting. Mr. Teague was cited for over capacity, found guilty in the Milwaukee Municipal Court and fined \$5,600.00 on April 4, 2002. In subsequent proceedings, the court reconsidered these citations and dismissed one-half of them, thereby reducing the fine to \$2,800.00.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Marlon K. Teague, has met the criteria to allow renewal of his Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license with a sixty (60) day suspension. The Committee finds those portions of the police report and neighborhood objections set forth in Paragraph 5, above, true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license of Marlon K. Teague for the premises located at 518 North Water Street in the City and County of Milwaukee, Wisconsin ("New Millennium Club") with a sixty (60) day suspension based upon his past

activities and for the danger that the continued operation of the premises poses to the health, safety and welfare of the citizens of the City of Milwaukee.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) no, recommends that the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) License of Marlon K. Teague for the premises located at 518 North Water Street ("New Millennium Club") in the City and County of Milwaukee, Wisconsin be renewed with a sixty (60) day suspension. Said suspension to be served from midnight July 28, 2002 through midnight, September 26, 2002.
