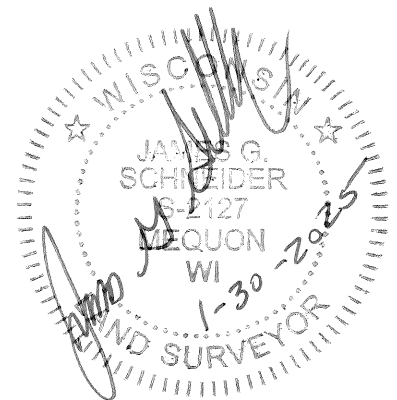
Location Map:
