We have received your claim in the amount of \$7,266.78, relating to your subrogation interests and the interests of your insured arising from a June 1, 2006 incident in which your insured's vehicle struck a vehicle owned by the Milwaukee Police Department (MPD) at North 7th Street and West North Avenue.

Our investigation reveals the MPD was following a vehicle pursuant to a drug dealing investigation. The detective driving the vehicle indicated he entered the intersection on a yellow traffic signal and the majority of his vehicle had cleared the intersection. Your insured struck the MPD vehicle in the rear of said vehicle because he immediately entered the intersection without checking to make sure it was clear of traffic. Since your insured failed to maintain look-out and struck the MPD vehicle that for the most part had cleared the intersection, the City cannot accept liability and we are denying your claim.
