**Dear Committee Members:** 

File 240160 would approve Amendment No. 2 to Tax Incremental District (TID) 85, 6<sup>th</sup> and National (the District), along with a corresponding plan. The Comptroller's Office has reviewed the project plan and feasibility study and has had discussions with the Department of City Development (DCD). The Comptroller's Office analysis is based on the information provided.

### **TID Background**

The District was created in 2015 (Common Council File No. 150654) to provide \$1,660,000 for the reconstruction of South 5th Street between West Virginia Street and West Scott Street, bike amenities, and \$25,000 for administration. In 2016 (File No. 151790), an additional \$815,000 funding increase was approved for the 5th Street reconstitution. In 2021 (File No. 210331), Amendment 1 was approved to provide \$900,000 for pedestrian and bike improvements to South 6th Street and West Mineral Street, \$250,000 for preliminary planning, design, and engineering for the Walker's Point extension of the Milwaukee Streetcar, \$50,000 for additional bikeshare stations and \$75,000 in administration, totaling \$3,775,000.

Amendment 2 would provide \$7,950,000 for public infrastructure improvements, \$500,000 for commercial corridor programs, and \$250,000 in administration, totaling \$8,700,000.

Please see Table 1 for details about public infrastructure and approximate associated costs to summarize the project plan better. Table 2 lists the Project Budget Revision Summary.

## Is This Project Likely to Succeed?

From a financial perspective, the proposed amendment will not adversely affect the District's ability to recover its costs over the life of the TID. The District's current TID increment value for the assessment year 2023 is \$60,116,600, generating an annual incremental value for the City of \$1,275,215 in only year 9 in this TID.

DCD's feasibility study, which uses a constant 2.121% property tax rate and 1% inflation rate over the life of the TID, forecasts that the TID will fully recover the \$8,700,000 plus interest in 2036 after receipt of the 2035 levy. This is year 21 of the TID's life and is well within a TID's typical life of 27 years. Therefore, the \$8,700,000 proposed amendment seems feasible based on the Comptroller's Office review.

#### **Sensitivity Analysis**

There is inherent risk in every projection of future results. One common way to evaluate this risk is to provide sensitivity analysis, which forecasts the impact that different assumptions have on the projection. Below is Table 3, which summarizes several scenarios to show the sensitivity of DCD's projected incremental revenues within the District. The analysis shows, even at 90% of projected revenue, the TID will recover in payback (budget) year 2037.

# Is the Proposed Level of City Financial Participation Required to Implement the Project?

This proposed amendment would allow public infrastructure improvements to be completed in this district. Without approval of this amendment, the City would have to find an alternative funding source to complete these activities.
