Enclosed is a resolution recommending settlement of the above-referenced matter, which we ask be introduced and referred to the Committee on Judiciary and Legislation for their recommendation.

Claimant, Linda Laura-Culbreath, through her attorneys, Simpson & Deardorff, S.C., alleges that on March 1, 2014, while in the scope of her employment as a City of Milwaukee DPW employee, she was involved in an automobile accident with an uninsured motorist, sustaining certain injuries and damages. The claimant has agreed to settle this claim for the amount of \$25,000.00.

Settlement of this claim is recommended based upon the reasons stated on the enclosed Settlement Draft Request from the law firm of Crivello Carlson, S.C. This firm has been retained to administer the City of Milwaukee's uninsured motorist self-insurance plan.
