## **NOTICE OF PUBLIC HEARING**

PLEASE NOTE: <u>A zoning change is being considered for the property within the boundary</u> shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet.

## **DEAR PERSON OF INTEREST:**

The Common Council has referred File No. 230192 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Two-Family Residential, RT4, to Local Business, LB2, on the property located at 1547 West Mineral Street to facilitate the expansion of an existing parking lot located at 1559 West Mineral Street, on the south side of West Mineral Street, east of South Cesar E. Chavez Drive, in the 12<sup>th</sup> Aldermanic District.

This zoning change was requested by Sixteenth Street Community Health Centers (SSCHC), which owns an existing parking lot at 1559 West Mineral Street. SSCHC is proposing to purchase 1547 West Mineral Street from the City of Milwaukee and combine it with 1559 West Mineral Street (zoned LB2) to expand the parking lot. SSCHC has a continued need for additional parking to provide access to their services in their Health Center. A zoning change is necessary to combine the properties, as mixed zoning on a lot is not allowed. The expansion of the parking lot will also require approval by the Board of Zoning Appeals. Please refer to the reverse side of this notice for map details.
