Dear Mr. Klamann and Attorney Cubbie:

This is to notify you that on June 9, 2003 the City's Utilities and Licenses Committee voted to recommend to the City's Common Council that your renewal application for a Class "B" Tavern and Tavern Dance Amusement (Cabaret/Nite Club) license for the premises at 4928 West Vliet Street, Milwaukee, Wisconsin ("O'Briens") be approved with a fifteen (15) day suspension. The Committee made such a recommendation based upon police report and neighborhood objections.

On June 12, 2003, you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Utilities and Licenses Committee with respect to your renewal application for a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license in which the Committee recommended that your renewal application be approved with a fifteen (15) day suspension. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of June 24, 2003 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections or to appear personally or by counsel to address the Common Council. At that date, time and place you did appear and were represented by Attorney Rodney Cubbie, and you filed written objections.

Following consideration of the report of the Utilities and Licenses Committee your objections and your arguments, a motion was adopted by the Milwaukee Common Council by a vote of twelve (12) ayes and four (4) noes to amend the Committee recommendation from a renewal with a fifteen day suspension to a renewal with a ten (10) day suspension. That recommendation was ultimately adopted by the Common Council by a vote of fifteen (15) ayes, one (1) no and zero (0) excused to renew your Class "B' Tavern and Tavern Dance License with a ten (10) day suspension.

Said suspension is to be in effect between midnight, June 23, 2003 and midnight, July 2, 2003.
