

CLAIM AND ITEMIZED RELIEF SOUGHT

Charles A. Weathersby, Jr., claimant herein, who resides at 2224A North Buffum Street, Milwaukee, Wisconsin 53212, hereby presents to the Clerk for the County of Milwaukee, a municipal governmental body and to the City of Milwaukee Department of Public Works, the following itemized statement of relief sought for the damages suffered on or about December 23, 2024, due to the negligence attributable to said municipal governmental body arising from a pot/sink hole which damaged claimant's 2005 GMC Yukon automobile.

1. Claimant is Charles A. Weathersby, Jr., who resides at 2224-A North Buffum Street, Milwaukee, Wisconsin 53212.
2. That on December 23, 2024, claimant was operating his 2005 GMC Yukon and was driving northbound on North Weil Street, at approximately 11:21 p.m., when his vehicle struck a large pot hole or sink hole that had opened up on the east side of the road, north of the intersection of North Weil Street and East Wright Street in Milwaukee, causing damages to claimant as indicated below.

That despite a worker for the City of Milwaukee being present at the scene, no attempts to block off the area to prevent other vehicles from hitting the hole had been made, prior to claimant entering it. That the City of Milwaukee was negligent in their failure to maintain its water pipes (believed to have had a pipe burst prior to this incident), failure to maintain their roads, failure to block off the road prior to claimant entering it, causing damage to his vehicle, and/or was otherwise negligent.

Claimant is seeking the payment, in United States Dollars, for the following items:

4. \$6,324.29, for towing and property damage to claimant's vehicle, as indicated in the attached tow receipt and estimate provided by Inland Auto.
5. Compensation for loss of use of vehicle of \$2,000.00

For a total claim of \$8,324.29

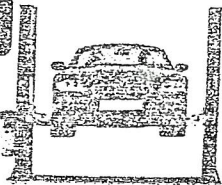

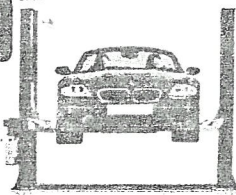
