Thank you so much for working on this issue, this has been a great help to the effected blocks on McKinley Blvd. The worries of car parts falling, noise and people racing over the speed burns, have been unfounded. We have noticed much less traffic in general and the cars cutting through from the gas station on 35th, have stopped coming all the way through. People do however slow down until they pass 31rst street, then fly the rest of the way to 35th.

It is unfortunate that we did not have these much earlier as it may have helped slow down other activities in the neighborhood, at this point we want to move out of the area. There have been several other crime related issues that lead us to that decision. We have now dropped the listing price on our house to \$40,000 below the city assessment and are still not having any luck. We have had people look and make statements regarding how great the house is, but the neighborhood is really bad. We may be stuck for some time or take a much larger loss, so again we greatly appreciate the speed bumps.

Thanks for the email. The McKinley speed humps are a demonstration. More speed humps will have to wait for an ordinance we are now drafting. I can say that several aldermen do not support these measures. There are many bureaucrats who do not like this idea. There will be a debate.

If we do approve a speed hump program the installations will be assessable public improvements like alleys, sidewalks and street reconstruction which means abutting property owners will pay part of the cost. This is the only way this can fly financially since we expect many requests and the cost is not insubstantial.

I am very happy to hear that you are taking the initiative to implement the speed bumps. We have been suggesting doing something like that on Juneau Avenue for about 20 years now. All we have ever gotten is excuses why the city could not do such a thing, e.g. it would be detrimental to emergency vehicles and snow plowing. The best we were able to get was a stop sign at a "T" intersection at 31st and Juneau Avenue that many drivers simply ignore. We have a couple irresponsible drivers who seem to enjoy driving through that stop sign as fast as they can. Because there are no cross streets between 29th Street and 33rd Street on Juneau Avenue there is a long stretch of road that some people treat as their personal drag strip. One day I was crossing Juneau Avenue near the stop sign to get to my car across the street and found myself in the middle of the street with a car coming at me after it had run the stop sign. Fortunately the driver was considerate enough to stop before he got to me and I did not have to try to decide which direction to leap to get out of his way. Stop signs are not the answer for people who do not respect them.

I would like to see two speed bumps on Juneau Avenue between 29th Street and 33rd Street: one just west of 30th Street and one just west of 31st Street. If this were done, I think it would be OK to remove the stop signs on Juneau Avenue at the intersection with 31st Street. Since the speed bumps would assure that cars would have to drive slowly, the stop signs would no longer be necessary. However, the stop sign on 31st Street at Juneau Avenue should be retained.

I think removing some of the stop signs on streets with speed bumps would be a good idea. On McKinley Blvd between 27th Street and 35th Street there are 4-way stop signs at every intersection. Driving east or west along McKinley can be very aggravating. I can see where the frequent stops might cause people to ignore some of the signs in order to get to their destinations in the neighborhood and contribute to their apathy concerning other stop signs. Having stop signs at every other intersection along with the speed bumps would be a reasonable compromise in my opinion.

Please keep me informed about developments in this area and let me know if there is anything I can do to help with the implementation of speed bumps on Juneau Avenue.
