It is with pleasure that I write a letter of support for MATA Community Media with whom Milwaukee Institute of Art & Design has partnered over the past six years or more.

MIAD Outreach programs serve many K-12 MPS schools with high quality art, design and technology programming. We rely on partners like MATA to make it possible for us to provide under-served youth and adults alike with technology training, career opportunity exposure and an understanding of resources that are available to them within their community. These offerings have also helped to supplement the dwindling art programming in the MPS schools due to recent deeply felt budget cuts. These offerings have also helped to give adults vocational training. They have helped to reinvigorate and retain teachers who needed support in motivating their students and using relevant technology as they teach across the curriculum.

MATA gives individuals voice that may not otherwise feel as though they are being heard. MIAD's Continuing Education program has collaboratively offered courses at and with MATA over the years that we would not otherwise have been able to offer. MIAD degree students have worked at MATA and benefited greatly from having their work aired on MATA's station. We have organized programs for our after school programs and with schools such as North Division high school. North Division has one of the lowest graduation rates in the city of Milwaukee. But 80 students worked with MATA and MIAD instructors and degree students to create video documentaries about Africa that included a live teleconference interview with Senator Russ Feingold about his involvement with the Senate Subcommitte on African Affairs.

MATA is an important institution in our city and one that is needed, especially as technology and media literacy become increasingly important. I sincerely hope that as you consider its funding status you will keep its impact and benefits to the people of the City of Milwaukee in mind.


