## Narrative (1)

### INITIAL INVESTIGATION

Borchert, Lori C 016019

07/07/2019

On Sunday, July 7th, 2019, at 9:36am, Squad 3140 (myself and PO Kyle JELINEK) was dispatched to an overdose at N. 22nd Street and W. Fond Du Lac Avenue, in the city and county of Milwaukee.

The driver, later identified as Julius T. DENTON (11-20-84), was unresponsive in the driver's seat upon our arrival and MFD (Lt. Belinda BRADLEY, Engine 13, grn shift) had already given him one dose of Narcan. He received two doses of Narcan and oxygen before he became responsive. After a second dose and oxygen DENTON did become responsive, but remained groggy. He was conveyed to Mt. Sinai Hospital by Curtis 311 for medical clearance. DENTON admitted that his passenger, identified as Rachel M. BIRKLEY (B/F, 11-28-97 of 2516 N. 22nd Street, 414-391-4993) had given him a blue pill which he called "fake percocet." He remembers being enroute to the store at N. 22nd Street and W. Meinecke Avenue.

DENTON was driving a 2013 blue Dodge Caravan with WI plate of 230UPK and vin #2C4RDGBG9DR792353) listing to JSC Inc. (American Cab Company). He had a Public Passenger Vehicle card on display (License #0208078 which expires 11-26-20).
