# 2 men abduct woman, rob her workplace

Two men kidnapped a 35-year-old employee of a check-cashing store at her home early Friday, tied up her daughter with duct tape and then forced the employee at gunpoint to the store, where they got away with a large amount of cash, Milwaukee police said.

The crime is similar to several others in which gunmen confronted bank or check-cashing store employees in their homes and then forced them to the business for money, police said.

The most recent one was Aug. 7, when two men took a woman from her home and

tried to get her to open a safe at the bank where she works.

In all, there have been 16 crimes in the past two years in Milwaukee in which gunmen held people against their will at some point during the robbery, police said.

Police think the robbers do surveillance on the employees before committing the crimes. They said they don't think it is a single pair of robbers who have been involved in all the incidents.

Police did not get surveillance video from the most recent crime, but they are pushing for a change to prevent future robberies. Police have asked the Milwaukee Common Council for an ordinance to require check-cashing stores to

have operating security cameras, Deputy Chief Brian O'Keefe said. He expects the council to act on the request next month.

The city requires certain businesses, such as convenience stores and gas stations, to have cameras, he said.

Friday, the two confronted the woman in her home in the 4700 block of N. 39th St. at 4:35 a.m., police spokesman Sgt. Ken Henning said. They bound her 15-year-old daughter and left for Milwaukee Checkcashers Inc., 4201 W. Capitol Drive, shortly after 7 a.m. in the woman's Pontiac Sunbird, Henning said. After getting money, the men fled in the car, which was found near N. 38th St. and W. Congress St., Henning said. No one was injured.
