Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 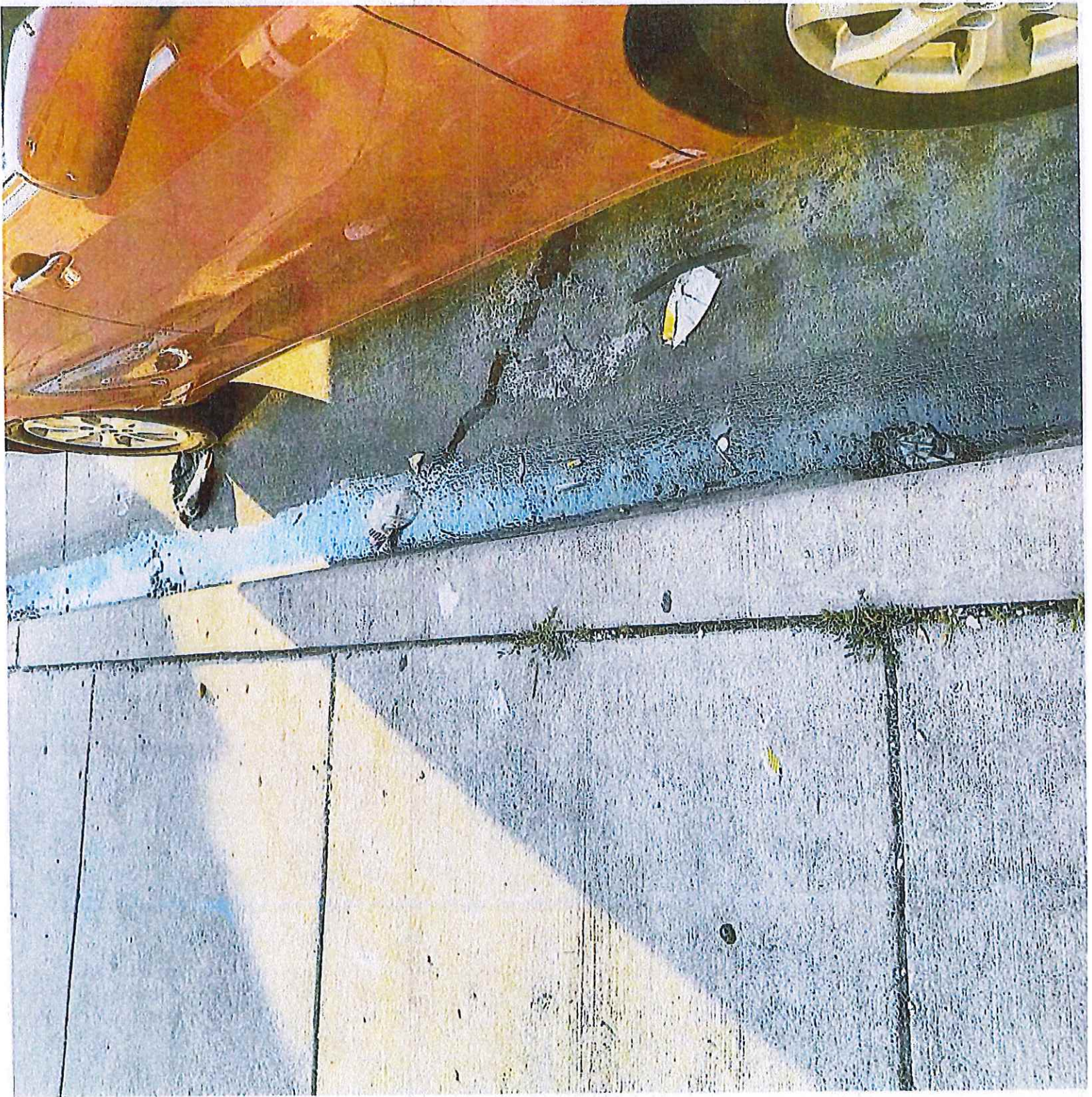

Thank you for the pictures sir! I had my staff enter a complaint this morning so someone from my staff should be going out there to check on it today if not first thing tomorrow.

Ultimately health can issue orders for the lack of a waste receptacle as well as liquid waste not being captured and held on premise until they return to their base for proper disposal. It does need to be verified at the time of our inspection in order for orders to be written.

Hey there,

Jumaane and I are chatting as we speak. So from our MHD department, we could issue a Special Inspection Report referencing this ordinance with a 30 day compliance for cleanup, they would get reinspection fees at each reinspection, (checked every 2 weeks- first is \$125, \$250, \$375, \$500) and at the 4th reinspection would be issued an Orders to Cease in addition to the fee if not addressed. Yes-this could be added to their licensing file when they come up for renewal.

Jumaane mentioned their department could also do some type of verbal order. MPD also has capabilities it sounds like with a PA-33. Again what is tricky is being able to tie it to the truck at the time of inspection. Our inspector went out yesterday to check on Mexi Cali and said at the time, it was a water leak and issued orders-attached- for both the leak and the waste receptacle. I am asking that when she goes back for the first reinspection she takes one of our Mobile Coordinators with to do another check for liquid waste. I do agree in the pictures you sent there seems to be liquid waste in the space.

I think the broader conversation to think on with these is if we want a dedicated enforcement mechanism for all things food trucks to not only stream line response but also have a regular clear go to place for all these issues, particularly late night like the tavern car. Madison has something like this. Due to the nature of these operations being mobile and the full range of hours it can make enforcement especially cumbersome. Just something to keep thinking on.

Alderman Westmoreland, let me know if you have any questions on the report. I will keep you posted on how the re inspections go.


