This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/07/2021 officers were dispatched to a Shot Spotter call at Gas N. Go, 1909 W. Hopkins St. The officers located a victim, who stated he was punched to the face several times and hit in the head with a pistol. The officers spoke with the clerk, who stated he heard two pops and saw someone running. The officers watched video surveillance, which did capture the incident. The video showed the suspect hit the victim and run off, pulling a gun and shooting at the victim two times. The victim was not hit by the shots fired.
2. On 03/22/2021 officers conducted a license premise check at Gas N. Go, 1909 W. Hopkins St. The officers spoke with the applicant regarding the Standing Complaint Form Program. The applicant did agree to participate in the program and signed the form.
3. On 04/12/2021 at 9:09pm officers conducted a license premise check at Singh Gas & Food), 1909 W. Hopkins St. The clerk was cooperative and provided all requested licenses.

4. On 02/17/23 Milwaukee Police were dispatched to 1909 W. Hopkins St, for a violation of restraining order complaint. Officers spoke with the caller/manager who stated that the business has a valid restraining order (R.O.) against a known subject. The subject came to the location and stood in the business parking but was now no longer on scene. The subject left prior to police arrival. Officers spoke with employee at the register who stated that the subject remained outside for approximately 27 minutes. Officers verified that the R. O. was valid and

requested a copy of the video of the incident, from the business. Officers checked the area for the suspect.

5. On 03/03/23 Milwaukee Police were dispatched to 1909 W. Hopkins St, for a violation of restraining order (R.O.) complaint. Officer spoke to the employee who stated that a known subject violated the R.O. the business has in place. The employee stated that the subject did come into the gas station and was told to leave. The subject eventually left and was observed walking west bound from the business. The business was cooperative with officers and allowed access of the video footage. Officers observed the subject on the video being on the premise and bothering patrons. Officers confirmed the R.O. was valid and checked the area for the subject.
6. 04/09/23 at 7:21pm, Milwaukee Police were dispatched to 1909 W. Hopkins St, for a fight complaint. Officers spoke to the agent who stated that the two subjects a mother and daughter have been arguing loudly for the past 30 minutes. The agent attempted to stop the subjects but they became more aggressive. Officers are familiar with the two subjects and were able to diffuse the argument. The subjects were then made to vacate the premise. The business was cooperative with the incident.
7. On 08/08/23 at 1:31a.m., Milwaukee Police were dispatched to 1909 W. Hopkins for a Subject with Gun. On arrival the officers observed a subject matching the description given by dispatch. After a short foot pursuit, the subject was taken into custody, however, no firearm was recovered and it was later determined this was not the subject listed in the CAD comments.
8. On 08/12/23 at 12:51a.m, Milwaukee Police were dispatched to 1909 W. Hopkins St., for a Shooting. Investigation revealed a subject was walking to his residence when they heard several gunshots and ran down the alley. The incident did not take place at the gas station; however, the employee did call the police for the victim.

9. On 11/22/23 at 5:46p.m., Milwaukee Police were dispatched to a Shoplifter at 1909 W. Hopkins. Investigation revealed the business was the victim of a retail theft. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
10. On 03/08/24 at 12:05a.m., Milwaukee Police were dispatched to a Subject with Weapon at 1909 W. Hopkins. Investigation revealed suspects entered the store with sticks, stole items, and vandalized the business. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
11. On 03/10/24 at 11:27p.m., Milwaukee Police were dispatched to a Robbery at 1909 W. Hopkins. Investigation revealed suspects kicked the locked cashier door open and knocked the cashier to the ground, kicking and punching the victim. The suspects then took money and tobacco from the cashier area and fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
12. On 03/17/24 at 8:10a.m., Milwaukee Police were dispatched to a Retail Theft at 1909 W. Hopkins. Investigation revealed the business was the victim of a retail theft. The business

stated they do not have security guards, however, are looking into the possibility in the near future. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

The following items pertain to 1909 W. Hopkins St., Gas N Go.

13. On 10/24/24, at 1:12 a.m., an officer was dispatched to a Robbery/ Shots Fired complaint. The robbery and shots fired were found to be baseless. It was determined that a suspect caused damage to a credit card reader after being stopped when attempting to steal items. The suspect was arrested on scene.
14. On 01/11/25, at 8:42 p.m., an officer conducted a License Premise check. All licenses and permits were up to date. Security cameras were working. Several expired food items were found on display and offered for sale. An employee was advised and removed the items.

LICENSED PREMISE REPORT

This report is being written by Police Officer David KLEIN assigned to District Five, Late Shift, Squad 5321.

On 10/24/2024 at 12:12 am at the location of 1901 West Hopkins Street (Gas N Go Convenience store), located in the city and county of Milwaukee, the suspect verbally identified as Vernon EVANS M/B 01/16/1980 intentionally and without consent used a rock to damage a credit card payment machine at the location after attempting to leave the location with merchandise he did not pay for. EVANS was confronted by the clerk at the store, Sukit SINGH M/W 07/05/1999, and EVANS began using vulgar, boisterous, and otherwise disorderly language and behavior. Officers arrived on scene and EVANS was taken into custody and later conveyed to District Five for processing. The entirety of the incident was captured on the store's surveillance cameras.

Initial Observations

The initial call for service was dispatched as an Armed Robbery with shots fired inside of the store. Both of these elements are unfounded and a language barrier between the caller (SINGH) and dispatch may have had part in the erroneous call type.

The location is a convenience store/ gas station. When i arrived I observed a credit card dangling by its cord. There was also a softball sized rock on the floor inside the store next to a empty glass liquor bottle.

When I arrived on scene EVANS was already handcuffed and detained standing inside of the store lobby. Once EVANS and SINGH began yelling at each other I placed EVANS in the back of my squad car to deescalate the situation.

Interview of Sukit SINGH M/W 07/05/1999

SINGH stated that EVANS frequently steals from the Gas N Go convenience store that he works at (1901 West Hopkins Street) and immediately recognized him when he walked into the store. SINGH stated that he told EVANS he is not allowed on the property and refused service to him. SINGH stated that EVANS had a 6 pack of toilet paper and a can of cat food that he attempted to leave the location with, but SINGH locked the door. SINGH stated that EVANS became upset and took a rock out of his pocket and used to it to destroy a credit card reader in the store without his consent. SINGH stated that at first he thought EVANS was pulling out a firearm. SINGH stated that EVANS also pulled out an empty liquor bottle and held it in his hand as an improvised weapon and began shouting profane statements at

SINGH. SINGH called police and shortly after EVANS was detained.

Video Surveillance

The video surveillance inside of the store corroborated SINGH's statements. The video showed EVANS inside of the store at 1:12 am on Cam 3 using a rock to damage the credit card reader machine and the entirety of the Incident. SINGH was sent an Axon video request for the video.

I arrived on scene in a marked Milwaukee Police Department (MPD) issued vehicle and in full duty uniform. I was equipped with my MPD issued Axon Body Worn camera, which was activated during portions of this investigation.

Upon arrival, I met with a female subject, who was identified as Balwinder K GILL (W/F 12-20-62), who was currently working at the gas station.

I advised GILL that I would be checking if the proper licenses were posted and were up to date, as well as checking miscellaneous items that were placed out for sale to the public.

I observed the following permits posted, as well as on the City of Milwaukee License Search website:

- *Filling Station - Issued date of 01-17-24 & expiration date of 01-31-25 - Pending Renewal - Issued date of 12-17-24 & expiration date of 01-31-26*
- *Food Retail Dealer - Issued date of 01-17-24 & expiration date of 01-31-25 - Pending Renewal - Issued date of 12-17-24 & expiration date of 01-31-26*
- *Cigarette and Tobacco - Issued date of 01-17-24 & expiration date of 01-31-25 - Pending Renewal - Issued date of 12-17-24 & expiration date of 01-31-26*

I also observed an Underground Storage Tank Permit to Operate. The permit had an issued date of 09-30-24 & an expiration date of 08-28-25.

I asked GILL if there are surveillance cameras on the interior and exterior of the gas station and GILL informed me that there are. GILL stated that there is a password posted on the wall for when/if police officers need to come review footage regarding incidents that may have occurred outside of the gas station or within close range.

I asked GILL if there are security officers that work at this location and GILL stated "sometimes", normally during the summer, but not currently right now.

I asked GILL how many employees work at this gas station and GILL informed me that it is usually her husband, her son, and herself. It appears that there are additional employees, as I spoke to one earlier, who was identified as Satwinderpal SINGH (W/M 07-05-99).

I asked GILL what the hours of operation were at this gas station and GILL informed me that it is open 24 hours a day/7 days a week. I was able to locate the hours of operation on the Milwaukee City License Search and the hours of operation are:

- *Sunday: 12:00 AM - 11:59 PM*
- *Monday: 12:00 AM - 11:59 PM*
- *Tuesday: 12:00 AM - 11:59 PM*
- *Wednesday: 12:00 AM - 11:59 PM*
- *Thursday: 12:00 AM - 11:59 PM*
- *Friday: 12:00 AM - 11:59 PM*
- *Saturday: 12:00 AM - 11:59 PM*

I informed GILL that I would be looking through items placed out for sale and that I would come speak with her when I was finished. Overall, the gas station appeared very clean and organized. During my check of expired items, I began to locate numerous items that were expired, such as chips, bakery items, milk, and a number of Starbucks coffee beverages. While I was checking the items, GILL informed me that her shift was over and that SINGH would be taking over for the night shift. I advised GILL that I located expired milk placed out for sale and GILL asked SINGH to take the expired milk out of the refrigerator.

Since GILL stated it was the end of her shift, I provided her with a Community Contact Card.

It was not until after GILL left, that I found the expired chips, bakery items and Starbucks coffee beverages.. I advised SINGH of the expired food/beverages, and SINGH immediately took the items off the shelf.

I asked SINGH if vendors come to the location to remove expired items and SINGH stated yes. I advised SINGH that next time he makes contact with any of these vendors, to advise him/her that there were numerous expired items and to conduct a better check on the expiration dates.

Overall, GILL and SINGH were very cooperative during my interaction with both of them.

I provided SINGH with a Community Contact Card.

On Tuesday February 4, 2025, I was dispatched to 1909 W. Hopkins St. for a Subject with a Weapon.

Upon our arrival, I observed the parking lot of the gas station empty and what appeared to be the employee's car parked on the side. I did not observe anyone in the store of the gas station.

I spoke to the caller, and employee identified as Satwinderpal SINGH (U/M, 07/05/1999 414-444-7638). They stated a male who frequently comes into the business and steal items, was inside of the store breaking property and he was outside with a gun. They stated the male comes in the store and take items. SINGH stated on 02/04/2025, the male subject came into the store and wanted to buy Tabaco products and tried to reach his hand under the glass to grab it. SINGH then stated the male continued to make threats towards him and curse at him. SINGH stated the male left the location when he told him he was calling the police.

The business was cooperative with the investigation. The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed a male subject standing by the front door and appeared to be talking to the worker. I observed other people in the store, in which, the male subject did not appear to bother them. The male at one point walked up to the glass and appeared to be on the
