AMENDMENT NO. 1 to Contract No. 05-094 (CM), dated August 22, 2005, between the City of Milwaukee through the Department of City Development and the Board of Regents of the University of Wisconsin System on behalf of the University of Wisconsin - Milwaukee

THE AGREEMENT, identified in the above caption by number between the City of Milwaukee (CITY) through the Department of City Development (DCD) and Board of Regents of the University of Wisconsin System on behalf of the University of Wisconsin - Milwaukee (UNIVERSITY), is hereby amended, modified, altered and changed in the following respects only.

WHEREAS, the extension clause, as approved by Common Council Resolution File No. 050357 was inadvertently omitted from the original agreement, which was executed by the parties; therefore it is necessary to amend Contract No. 05-094 (CM) to include the extension clause and to make minor corrections in the text of the agreement;

NOW, THEREFORE, the parties hereto do mutually agree as follows:

1. On Page 1, Time of Performance, is amended as follows:

"To commence on the date of execution of this Agreement, for a period of

one year."; and

INSERT: "To commence on the date of execution of this Agreement, for a period of

one year. This Agreement may be extended on the same terms and conditions for up to two additional one-year periods, by written

amendment signed by the parties."

2. On Page 2, make the following changes:
