Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/31/17 Milwaukee Police responded to 4221 W. North Av. (Domino's Pizza) for a Burglary. The agent, John Theisen, was cooperative and showed officers the surveillance video of three suspects use a pry bar to enter the business and burglarize the business.

2. On 06/11/23 Milwaukee Police were dispatched to 4221 W. North Av, at 12:53pm for a shooting complaint. The victim, delivery driver, came into the store limping and had been shot. Investigation revealed that the armed robbery and shooting incident happened near N 34th St and W Hadley St. Employees of the business were uncooperative and did not show officers video alleging the cameras were only for display. The delivery driver was arrested after medical clearance for a probation violation and due to drugs being found in his delivery vehicle.

3. On 08/13/23 at 2:37am Milwaukee Police were dispatched to 4221 W. North Av, for a subject with a gun complaint. Officers spoke with the employee/victim who stated that she and a coworker were closing the business for the night. The suspect arrived and pointed the gun and ordered them back in the store. The employees were able to get into the store and locked the door before the suspect entered. The suspect hit the window with his gun but eventually fled the area on foot. The employees were cooperative with the investigation, however they were unable to access the video cameras.

This report is written by PO Justino RODRIGUEZ, assigned to District Seven Early Power Shift.

On Sunday, June 11, 2023, I (Squad 7270) responded to 4211 W North Ave., regarding a Shooting complaint.

Upon arrival, I spoke to the caller/witness, who verbally identified herself as Jeniyae L. SUMLIN (B/F, 1/14/2004). SUMLIN stated that around 12:48 PM, she was working behind the counter, when the victim (Dion D. CARROLL B/M, 9/22/1989) walked into the business (Dominos) limping. SUMLIN stated that she then inquired about CARROLL limping, and she stated that he advised her that he was robbed and shot for the food order he was delivering. SUMLIN stated that CARROLL then began walking back and forth from his vehicle (Brown 2010 Chevy Equinox, Plate# ARV-2280) that was parked on W North Ave in front of the business to the store and stated that she and her co-workers had to encourage CARROLL to stay inside the business.

SUMLIN stated that she observed CARROLL to have a bullet hole to his pants but stated that she didn't observe any blood. When asked about the surveillance, SUMLIN and her co-workers stated that none of the cameras work and are just for display. We believe that this information is false due to Sgt. PUGLEY physically observing a live feed on one of the monitors upon responding to scene.

While on scene, I did not observe any signage postage regarding the businesses current license status.

During my investigation, I didn't observe any particular license violations with the business but did observe that the employees were uncooperative with law enforcement in showing the video regarding the incident.

Additional information obtained from supplemental reports:

Interviews by responding detectives revealed the delivery driver was shot while making a pizza delivery near N 34th St and W Hadley St.

The delivery driver was arrested after he received medical care for a probation violation. The investigating officers were also going to refer drug charges to the District Attorney's Office after drugs were located in the driver's vehicle during a consent search.

This report is written by P.O. Edward TRENSCH, assigned to District 3, Late Shift.

On Sunday, August 13, 2023, at approximately 2:37am, while assigned to Squad 3332 with P.O. Darell OWENS, we were dispatched to a Subject with Gun complaint at Domino's Pizza (4211 W North Ave), located in the City and County of Milwaukee.

Upon arrival, I observed the address to be a Domino's Pizza restaurant with a north facing front door. I observed multiple squads (3351, 3369, 3312) already on scene. I observed P.O. KISSLER speaking to a female outside of the restaurant, later identified as Angie A STOKES-JONES (b/f 08-07-86), I also observed another employee identified as Brandon M POHL (w/m 02-29-96) also standing outside.

After debriefing with officers on scene, P.O. OWENS spoke to the caller/victim, STOKES-JONES. STOKES-JONES stated she and POHL were closing the store for the night. STOKES-JONES stated POHL exited the building first but while exiting the front door she observed an unknown suspect described as a skinny tall black male wearing a black ski mask with holes in it, a "hoodie" with black and grey letters on it. STOKES-JONES stated the unknown suspect was pointing a black and silver handgun at her. STOKES-JONES stated the unknown suspect stated, "get back in the store". STOKES-JONES stated she grabbed POHL by the shirt pulling him back into the building. STOKES-JONES stated she then locked the doors. STOKES-JONES stated the unknown suspect then went up to the glass window hitting the window with his handgun. STOKES-JONES stated the unknown suspect then ran westbound towards N Sherman Bl. STOKES-JONES was cooperative with the investigation, due to her being a victim of an attempted armed robbery. The business had no security officers on scene.

STOKES-JONES stated that she was unable to access the video surveillance.

While on scene, I observed the licenses posted and they were up to date. During my investigation, for an attempted armed robbery that occurred outside of the business, I did not observe any violations in the licensed premise.

The hearing before the Licenses Committee will take place on 10/17/2023 at 10:55 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


