
Justification for Waiver:

In 2018, Career Plus served 296 youth, fulfilling the intent and annual expectations of this contract.


Justification for Waiver:

Purpose of Amendment:


Justification for Waiver:

The Board of Regents of the UW System on behalf of the UW-Milwaukee (Helen Bader School of Social Welfare & Zilber School of Public Health) implements the Program Evaluation for the Resiliency in Communities After Stress and Trauma (ReCAST) Grant federal grant, of which the Needs Assessment was a vital piece. Dr. David Pate is the lead Evaluator. Dr. Pate has completed the Needs Assessment stage of the project, and is continuing on to fulfill the ongoing program evaluation needs of the project. Dr. Pate has contacted 100% of ReCAST contracted partners to collect quarterly reporting data, has taken steps such as focus groups to collect and analyze qualitative data, and is working to develop outcome evaluation and reporting mechanisms related to each contracted partner. In 2018, UWM performed evaluation tasks related to each contracted ReCAST partner, fulfilling the intent and annual expectations of this contract.

The resolution regarding this use of the ReCAST Grant, from the United States Department of Health and Human Services, was adopted and passed by the Common Council on 09/05/2018 (File #180751), which identifies the Board of Regents of the UW System on behalf of the UW-Milwaukee (Helen Bader School of Social Welfare & Zilber School of Public Health) as one of the contractors. Purpose of Amendment:

The purpose of this amendment is to increase the estimated contract total of the Milwaukee Health Department's Office of Violence Prevention's Vendor Service Contract for Parenting Workshops by \$50,000.00 from \$100,000.00 to \$150,000.00.

Justification for Waiver:

The Parenting Network has many existing coalitions with neighborhood associations, faith institutions, and youth centers (e.g., Heartlove Place; Metcalfe Community Bridges; and Christ St. Peter Lutheran School). They implement evidence-based curricula including: Celebrating Families, Anger Management, Triple P, and the Strengthening Families Program. They have used the Parent Café approach to increase parent engagement and education since 2014, targeting low-income neighborhoods. This model, developed by the Center for the Study of Social Policy's Strengthening Families Initiative, introduces parents to protective factors necessary for building strong families and provides an opportunity for peer engagement. This model also prepares parents to be café hosts and help to facilitate workshops citywide. This model will be expanded to benefit more high-risk families, serving the "peer support" role and will participate in the coalition. In 2018, the Parent Cafés served 120 parents and/or caregivers.

The resolution regarding this use of the Violence Protection Recast Milwaukee Project Grant, from the United States Department of Health and Human Services, was adopted and passed by the Common Council on September 25, 2018 (File #180751), which identifies The Parenting Network as one of the contractors. For this reason and in accordance with City Charter 16-05-4a, Finance and Personnel Committee approval is waived for services authorized by the Common Council.

Purpose of Amendment:

This amendment will increase the estimated contract total by \$50,218.00 from \$280,261.00 to \$330,479.00. The purpose of this contract is to continue to provide ongoing upgrades, maintenance, and support services for Milwaukee Police Department's (MPD) NICE (911) Recording System, and this amendment will provide the Department the NICE Analytics Module for the duration of the contract. \$32,300.00 of the \$50,218.00 is for purchasing licenses for the NICE Analytics Module and the remaining \$18,918.00 covers maintenance and warranties for the duration of the contract.

The NICE Analytics Module provides improved quality, analysis, processing of, and dispatching of 911 calls verifying that calls are handled according to National Emergency Number Association (NENA) and Association of Public Safety Communications Officials International (APCO) industry standards. The application provides reporting capabilities for requests received from the Fire & Police Commission and MPD Command Staff.

Justification for Waiver:

This software is proprietary to NICE Systems (the manufacturer). The upgrades, maintenance, and support can only be provided by NICE Systems or Word Systems, Inc. The rates originally provided by NICE Systems were significantly higher than the current vendor (Word Systems, Inc.), and Word Systems, Inc. is the only authorized provider for this hardware and software in the state of Wisconsin.

For this reason and in accordance with City Charter 16-05-4a, Finance and Personnel Committee approval is waived for services authorized by the Common Council.

Purpose of Contract/Amendment:

This represents the seventh (7th) amendment request by the Police Department to the original contract amount of \$126,249.00. This amendment extends the contract to cover the original 2.0 square mile deployment, 3.5 square mile expansion in the North Area and the 4.5 square mile expansion in the North and South Areas for a one (1) year term from 04/01/2019 through 03/31/2020 for the current total coverage of 11.46 miles, and increases the estimated contract total by \$467,087.25 from \$1,764,707.00 to \$2,231,794.25. The gunshot detection sensor measurement system is not based on an exact science, therefore the 11.46 miles, on record, effectively yields an extra mile of coverage for an actual total of 12.46 miles.

Amendment No. 7 will cover an additional full year of service for the entire service area of 12.46 miles at a cost of \$467,087.00.


Justification for Waiver:

Since the establishment of this contract 2014, the MHD Lab has been utilizing the Abbott Architect i1000 Instrument to provide sexually transmitted infection (STI) testing – including, but not limited to, the Human Immunodeficiency Virus (HIV) –for the community at the Keenan Health Center. Annually, the MHD Lab utilizes the Abbott Architect i1000 device to provide approximately 3,500 HIV tests. The implementation of this amendment will allow the MHD Lab to continue to expedite HIV testing, as well as to begin providing an estimated average of 4,000 syphilis tests per year to the community.

For this reason and in accordance with City Charter 16-05-4a, Finance and Personnel Committee approval is waived for services authorized by the Common Council.

Purpose of Contract:


Per Council Resolution file #181282 (Attachment A), the Environmental Collaboration Office (ECO) is authorized to accept and fund an Energy Innovation Grant from the Public Service Commission of Wisconsin's Office of Energy Innovation to develop a Comprehensive Energy Plan for municipal buildings and fleet vehicles. Edison Energy, LLC will be partnering with ECO to develop the Comprehensive Energy Plan for the City of Milwaukee that will provide the foundation for all activities related to energy efficiency, optimization, transportation, sustainability, renewable energy, and procurement. This body of work will build off and complement the prior work that Edison Energy, LLC has already performed including: a Preliminary Energy Reduction Study, Retro-commissioning services, and Express Building Tune-ups. It is recommended that Edison Energy, LLC be awarded a Single Source Vendor Service Contract in the total amount allowed by the grant, \$160,900.00, from the date of award through the end of the grant period, 12/31/2019, with the option to extend annually upon mutual consent.

Since 2016, Edison Energy, LLC has been working with ECO and the Energy Reduction Team to perform energy assessments and energy reduction recommendations for the City's portfolio of buildings. This work has primarily been paid for by leveraging Focus on Energy incentive funds. In the process of conducting the energy assessments, Edison Energy, LLC has visited the majority of City-owned buildings thereby gaining a thorough understanding of the building's systems and mechanicals. As a result of the work already performed, Edison Energy, LLC is uniquely qualified to work with ECO and the Energy Reduction Team to create a Comprehensive Energy Plan for the City of Milwaukee. Additionally, Edison Energy, LLC:

- Has knowledge of City buildings' mechanicals and systems eliminates the need for initial site visits and the engineer's time to investigate and learn the systems thereby significantly reducing the cost and time involved;
- Has established working relationships and trust with City's facilities team thereby eliminating the need to cultivate the working relationship and trust; and
- Has proven to provide high quality work in a timely manner

Justification for Waiver:

Per resolution file #181282 adopted by Common Council on 12/18/2018, Edison Energy was approved as a contractor for this project. Edison Energy, LLC prepared the Preliminary Energy Study which provides the foundation for the next body of work. They are uniquely qualified as they have thorough background knowledge about the City portfolio of buildings and the City Facilities Team. This partnership between the City and Edison Energy, LLC was considered during the grant award process. For this reason and in accordance with City Charter 16-05-4a, Finance and Personnel Committee approval is waived for services authorized by the Common Council.
