2020 contract requirements:

- Provide women's health family planning services, following Providing Quality Family Planning Services: Recommendations of CDC, to men and women throughout the contract year; services such as STD testing, treating and retesting, provide the first three months of primary contraception method, reproductive life planning, pregnancy testing, and Dual Protection kits.
- Maintain clinical practice provision quality through DHS medical oversight.
- Collect and report into REDCap WHFP performance measures, demographic, STD and patient services data.
- Enroll clients in ForwardHealth Family Planning Only services and assure someone from MHD is signed up to receive ForwardHealth updates.
