Mr. Ovbiagele,

I am in receipt of the attached Subpoena issued by the City of Milwaukee Licenses Committee. It was served at the local facility, Wisconsin Avenue Dialysis, this morning. I understand that you are legal counsel for the business involved in this issue/dispute with the Licenses Committee over what I assume is the revocation of a business license. I also understand that there is the potential that a current or former patient may have been involved in a shooting at this particular business.

What I am not understanding is why DaVita would be receiving a subpoena to appear and give testimony about a business license revocation proceeding involving your client. Given applicable laws protecting patient and health privacy, we are not even able to confirm whether or not the individual was or is receiving treatment at DaVita.

I am happy to discuss further at your convenience, but it appears that I have less than 48 hours to retain counsel to quash this subpoena. Unless I hear from you in fairly short order, I will proceed to retaining outside counsel to quash the subpoena and, if available, seek fees and/or expenses for the cost of doing so.
