Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 3. On 08/21/24 at 10:12a.m., Milwaukee Police conducted a License Premise Check at 4704 W. Burleigh. Assisting in this were Agents from Wisconsin Department of Revenue Alcohol and Tobacco. The Agents confiscated numerous packages/cartons of tobacco deemed not legal for sale.
4. On 01/06/25 at 7:50a.m., Milwaukee Police were dispatched to an Entry at 4704 W. Burleigh. Investigation revealed suspect(s) entered the business via making a hold in the roof and climbed down. US Currency and cartons of cigarettes were obtained. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

On Monday, January 6, 2025, at 7:50 AM, Squad 7330 (PO Trenton BOSCHKE and I) were dispatched to an Entry Complaint at 4704 W Burleigh St, 53210. This incident was determined to have started at approximately 4:30 AM and ended at approximately 5:10 AM on 01-06-2024 at 4704 W Burleigh St, 53210. This premise is located in the City and County of Milwaukee, Wisconsin.

Upon arrival I observed the smoke shop portion of the store to have broken glass separating the common area of the store from the interior of the cashier counter of the smoke shop. I observed various boxes to appear ransacked or cast aside. Located near the rear exit door on the north side of the building was an ATM machine. This ATM was opened and empty and had several bottles of bleach tossed inside. There was also a smell of bleach near this area. Behind the cashier counter of the smoke shop was a ladder leading up into the ceiling. Between the ceiling and roof was a small crawl space that I cleared of suspects. I climbed up this ladder and observed a hole in the roof that the suspect would have entered through. I cleared this roof of suspects as well.

We spoke to the owner of the shop (Jordan Food & Tobacco), Mahmoud AL-GHROUZ (A/M 06-27-1972). Mahmoud advised us that he had done an inventory of stolen items which are listed as the following:

Six buckets of spare change from behind the front store counter (\$700 each bucket)

\$400 in various US currency bill denominations from cash register behind front store counter.

110 cartons of cigarettes from behind front store counter (Newport, Maverick, American Spirit, Misty)

I reviewed various camera angles from inside the store and was able to observe the suspect (U/M, medium complexion, 5'10-6'02, medium build, black hoodie, dark pants, dark gloves, black ski mask, white shoes possibly Air Force 1's) as he made his way around the store. The suspect can first be seen moving around the smoke shop portion of the shop before breaking through and making entry into the common area of the store. The suspect then moves towards the ATM and breaks into it. The area surrounding the ATM is dark and at times difficult to see the suspect's actions on camera, however it is clearly unbroken prior to the suspect entering and opened at the time of the suspect leaving. Once the suspect is done near the ATM, he enters behind the front cashier's counter of the store. The suspect is then scene ransacking the cash register and taking various cigarette products. The suspect then goes back to the area of the ATM for several minutes. The suspect then returns behind the cashier's counter and takes several buckets of change. Several minutes later, the suspect can be seen exiting the store out of the back door, carrying a white garbage bag over his shoulder and wheeling a dolly with the change buckets on it. The suspect then leaves eastbound in the alley behind the store that runs parallel to W Burleigh St. It should be noted that the night vision that is on several of the cameras depicts the suspects hoodie as light colored, however the cameras that captured the suspect in color show the appropriate color clothing.

The store was cooperative with the investigation and allowed us to view footage and remain on scene as long as we needed to. I did not observe any security guards on scene at the time of the investigation.

On February 16, 2025, at approximately 5:04pm, PO Samuel SCHWABENLANDER and PO Jamahl WRIGHT (Squad 7288), PO Shaundae MCINTOSH and PO Anthony JARAMILLO (Squad 7250) and my partner PO CHANDLER and I were dispatched to 4704 W Burleigh Street for a "Shooting" call for service.

Upon arrival, I observed the victim OBAIDI AMER W/M (03/24/2000) located on the southside of the front door. I observed the cashier Mohammed ALGHROUZ W/M (08/20/2006) trying to assist AMER who was on the ground suffering from a gunshot wound. PO SWABENLANDER, PO MCINTOSH and PO CHANDLER all arrived on scene and began assisting the victim AMER who had been struck once to the neck. The Milwaukee Fire Department Engine 34 and Med 13 arrived on scene to medically treat AMER. AMER was later transported to Froedtert Hospital regarding his injuries.

PO CHANDLER reviewed camera footage of the incident that occurred, which revealed that the incident occurred inside of the Jordan Food and Tobacco store. Upon reviewing the video, which had a time stamp of 4:58pm, I observed the victim AMER sitting on a ice cream freezer. I then observed the suspect, which is described as a (black, male, slim build, medium complexion, 6'0, 20-25 years of age, wearing red lense Cartiers glasses , wearing a gray and white shirt, black hooded sweatshirt, black coat, black skinny jeans, black and white Nike shoes) armed with a handgun.

Also while reviewing the cameras I noticed that the unknown suspect had been hanging out inside of the store for over four hours earlier the same day. While reviewing the footage I observed the suspect pull out a handgun and pointed the firearm at ALGHROUZ at approximately 2:44pm. The video also showed the unknown suspect dealing drugs also known as a hand to hand transaction to one subject inside of the business and to two subjects located outside of the business. While on scene PO MCINTOSH spoke with ALGHROUZ about the incident, during the conversation it was revealed that ALGHROUZ was not being truthful for how long the suspect had been inside of the store.

I spoke with the owner Mahmoud Abdelrahman AL-GHROUZ W/M (06/27/1972) who was the owner of Jordan Food and Tobacco and I let him know that a license premise report was going to be filed and that I would be mailing him a Pre-nuisance letter regarding the shooting incident.
