There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; thef; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with
warrants or unpaid fines:Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the
above date and time. Failure to comply with this requirement may result in a delay of the
granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The applicant was convicted in item #1. The applicant signed the form and swore under oath before a Notary Public that the information on the form was true and correct. When the applicant was asked why he answered no, he stated he did not remember the citation. When told what the violation was, the applicant stated that he now remembered the citation, but his lawyer filled out the application.

3. On 08/13/2008 a Milwaukee Police officer was working the Wisconsin WINS tobacco initiative. During this initiative, a 16 year old was able to purchase cigarettes from the applicant at 130 N. Water Street (Circle K Pantry). The applicant was issued citation #6032466-6 for Tobacco Sale to Minor. Milwaukee Municipal Court has no record of this citation number or of any other citation issued regarding this incident.

4. On 11/05/10 at 4:35 pm, Milwaukee police were conducting Sales of Alcohol to Minors and had a police aide, who is under the age of 21, enter 130 N Water in attempts to purchase alcohol. The clerk, identified as Zaid Kaid, failed to ask for ID when the aide brought up to the counter a six-pack of New Belgium Brewing Co. Fat Tire Beer. The applicant received a citation for Sale of Alcohol to Underage Person at 130 N Water Street.

5. On 12/15/12, Milwaukee police worked the Wisconsin WINS tobacco Initiative and had an underage student enter 130 N Water Street in attempts to purchase tobacco products. The student was able to buy a flavored Black and Mild cigar from the cashier who was identified as Ziad Kaid even though Kaid viewed the students ID. A citation was issued to Kaid which was dismissed w/o prejudice on 04/09/13. 13006644.

 On 02/27/2015 a 18 year old Milwaukee police aide, working in conjunction with Milwaukee police, was turned away at the point of sale at 130 North Water Street (Circle K Pantry) when she could not produce proof she had attained the legal drinking age of 21.

7. On 06/10/24, Milwaukee Police were assigned to work Wisconsin WINS, which checks area vendors for age compliant tobacco sales. At approximately 2:58p.m., a youth entered 130 N. Water and purchased tobacco from the cashier, who was later

identified as the agent. The agent admitted to the sale, however, stated the youth's date of birth was proper for the sale. The officer provided the ID to the Agent; however, the agent became angry stating the youth showed a different ID and the Police Department was setting them up and attacking business owners. The agent was cited for the violation.

This report is written by P.O. Eric Schilling-Mess, assigned to the Office of Community Relations, Engagement, and Recruitment Days, equipped with a working Body Camera and Full MPD Uniform.

On Monday, June 10, 2024, at approximately 2:58p, I conducted an investigation at the location 130 N Water (Located in the City and County of Milwaukee) This was in partnership with the Memorandum of Understanding with Community Advocates, Coalition Coordinator the City of Milwaukee Tobacco-Free Alliance, Charlie Leonard. Wisconsin Wins Campaign (WI WINS is an intervention program designed to help the State of Wisconsin come into and stay in compliance with requirements of the federal Synar Regulations.

The two teens that were assigned to this deployment were as follows:

Ashleigh Contreras (W/F, 08/08/2006)

Marcel M Griffin (B/M 10/26/2006)

Upon arrival to the location, CONTRERAS and GRIFFIN entered the location attempting to purchase products for sale, not intended for minors. The goal was for the organization to request identification and turn the minors away after they found out the teens were and ineligible for the sale. CONTRERAS requested pack Zyn Nicotine Pouches from the cashier. The cashier requested for her identification, to which she complied. CONTRERAS a provided her ID which indicated that she was 17 years of age. CONTRERAS further stated that cashier appeared to look at the identification. The cashier ultimately sold the ZYN Smooth pouches at the cost of \$7.99. CONTRERAS and GRIFFIN returned the vehicle and provided me the description of the person hold sold the item to them, who was the only cashier on duty.

I then entered the location and requested a manager. The cashier stated that he was the manager and the agent for the business. He identified himself as Ziad KAID by his Wisconsin Identification Card. I explained the circumstances of the sale to a minor. KAID was visibly upset and stated that the age on the ID from CONTRERAS was of the age for proper sale. I then stated that she is 17 years of age and requested proof. I obtained CONTRERAS's ID card and presented the year and dates on the KAID. KAID then accused the police department of setting him up, and that CONTRERAS provided him with a different ID. KAID then complained about the investigation and response times and then accused MPD of attacking business owners. At this point, KAID's son arrived at the location, and I explained the same thing about the investigation. KAID's son stated that he had seen CONTRERAS before at his other store when he didn't make a sale a few weeks prior. I advised him that he was right in doing so, however, this

The hearing before the Licenses Committee will take place on 12/3/2024 at 9:45 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
