**W. Fiebrantz Ave. – N. 68th St. to W. Beckett Ave. (ST211100116):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7 – 8-foot width of tree border area), and grading.

**W. Perkins Pl. – W. Beckett Ave. to W. Appleton Ave. (ST211100119):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-foot width of tree border area), and grading.
