There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Alderman Stamper,

We do have an open order from February for Dominos to correct the dumpster location.

I reached out to the building owners last week and was told that the building has new ownership. There is no record of an ownership transfer as of yet.

The former operators told me that the building was under control of Sajan properties. This is the same owner of the MO CUTS property. (I did talk to them today as well). Sajan (414-324-7954) did not return phone calls.

After reaching out to the license holder (John Theisen 414 350 7465) for Dominos he believes that he is the winning bidder of the foreclosure and that he will have control of the property in the next few weeks.

I informed him that the dumpster has to be moved back to the original location in the rear of the building, until he can secure permits and BOZA approval to build a dumpster corral on 42nd street

The employees were not forthcoming with officers and stated video surveillance was for display only, however, officers observed the video surveillance was functional. The driver was later arrested for a Probation Violation after drug's were located in the driver's vehicle.
 2. On 08/13/23 at 2:37a.m., Milwaukee Police were dispatched to a Subject with Gun at 4211 W. North Ave. Officers were advised by an employee as they were closing for the night a suspect approached armed with a firearm and told them to get back into the store. The two employees retreated into the store and locked the door. The suspect fled on foot. The employee stated they did not have access to video surveillance.

3. On 10/23/23 at 7:01p.m., Milwaukee Police were dispatched to a Battery Cutting at 4211 W. North Ave. Investigation revealed a victim was stabbed elsewhere and ran into the store for help. All employees interviewed stated the victim came in, took their shirt off and was bleeding. The victim was conveyed to a local hospital. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is written by Police Officer Benjamin WRIGHT assigned to the Milwaukee Police Department's Third District, Late Power Shift.

On Monday, October 23, 2023 at 7:01 PM, Squad 3430 (P.O. Richard TOLENTINO and I) was dispatched to a Battery Cutting complaint at Domino's Pizza, 4211 W. North Ave., which is located in the City and County of Milwaukee, Wisconsin.

En route, Squad 3430 read the Computer Aided Dispatch (CAD) message which stated, "CLLR STS A CUSTOMER WALKED IN AND STS HE WAS STABBED IN THE BACK."

At 7:09 PM, Squad 3292 (P.O. Randal PEREZ) arrived on scene, and was notified by Milwaukee Fire Department (MFD) MED 13 was treating the patient, later identified as John H. SKENANDORE (m/w, 09-11-05), for a laceration to the center of his upper back. SKENANDORE was conveyed to Froedtert Hospital by MED 13 with Squad 3292 following. At 7:23 PM, SKENANDORE was admitted to the Hospital under the treatment of Dr. Anna CULHANE (See P.O. PEREZ's Supplemental Report).

On scene, Squad 3430 spoke with the following employees of Domino's Pizza in the food preparation area:

INTERVIEW OF ZARIAH A. SIMS

I spoke with Assistant Manager Zariah A. SIMS (f/b, 01-02-97) who stated it was her first day of work. SIMS expressed at approximately 6:50 PM, she saw a male run into the store. The male came in the store and stood in the corner. SIMS said another customer told the victim he was bleeding.

INTERVIEW OF TREVEON W. RAINEY

P.O. TOLENTINO spoke with Treveon W. RAINEY (m/b, 03-26-96) who said he was making pizzas when the victim came in. RAINEY said the victim stood in the lobby, took off his shirt, and people saw that he was bleeding.

INTERVIEW OF MIGUEL A. ARRIOJAS-CORTES

I spoke with Miguel A. ARRIOJAS-CORTES (m/w, 07-31-04) who said he was preparing pizzas when the victim entered the lobby. ARRIOJAS-CORTES said the victim spoke with another man in the lobby, and

took his shirt off. ARRIOJAS-CORTES said he observed a laceration in the center of the victim's upper back. ARRIOJAS-CORTES called 9-1-1 regarding the incident.

Area Manager William R. ALDEN (m/w, 08-07-89) responded to the scene to allow officers to observe surveillance footage of the incident (See P.O. TOLENTINO's Supplemental Report). ALDEN was cooperative with the investigation.

The hearing before the Licenses Committee will take place on 10/22/2024 at 2:55 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


