I am writing to formally appeal THE NOTICE OF NUISANCE regarding the ongoing challenges of homelessness and illicit activities occurring around my property located at 1417 S 12th Sr/ 1201-1205 W Greenfield Ave. It seems that there have been 4 incidents which have occurred between May 30th 2025 to July 15th 2025 which have brought unwanted problems and unwanted attention to the property, I have attached a copy of the 4 incidents to this form

I want to make clear that I have never had these types incidents or issues on this premises since I took ownership Since I have received this notice I have a plan to help mitigate the situation, I plan to institute the following changes and actions

Installation of "No Trespassing" signs.

Improved lighting around the property.

Set up Regular Communications, with the police chief and the alderman to notify of any issues that might arise

Encourage the tenants in the premises to report any unwanted activities to both the Landlord and the police, whenever appropriate

I want the Police and City Of Milwaukee officials to understand the limitations that I am facing in dealing with these problems as they occur in public spaces, and involve individuals to whom I have to direct connection. I realize that this all is a result of broader social challenges such as homelessness, and drug use which require community-wide efforts to address.

I am asking the City of Milwaukee for support in finding more sustainable, long-term solutions for managing the homeless and drug use situations in this area. I ask the City to reconsider its decision to fine me as this is the 1st time I have been in this situation. Please also consider that the money to pay these fines can be better utilized to improve the property to discourage this type of activity in the future

In Conclusion I want to Reiterate my ongoing commitment to maintaining the safety and security of my property
