
Dear Complainants:

This is to notify you that on June 14, 2002, the City's Utilities and Licenses Committee voted to recommend to the City's Common Council that the renewal application for a rooming house license for the premise at 902 South 3<sup>rd</sup> Street, Milwaukee, Wisconsin be renewed.

On June 17, 2002, you were sent a true and correct copy of the Findings of Fact, Conclusions of Law and Recommendations of the Utilities and Licenses Committee with respect to the renewal application for a rooming house license in which the Committee recommended that the renewal application be approved. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of June 25, 2002, commencing at 9:30 a.m., in the Common Council chambers, on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections and to appear personally or by representative to address the Common Council. At that date, time and place you did not appear, nor did you file written objections to the report of the Utilities and Licenses Committee.

Following consideration of the report of the Utilities and Licenses Committee, the Common Council adopted the Committee's recommendation by a vote of sixteen (16) Ayes, zero (0) Noes and one (1) Excused to renew the rooming house license.
