Dear Alderman Bauman,

I nominated the Historic District that is the subject of item #6 on the ZND Agenda for next week, but I will not be able to appear at the hearing.

This week, I was discharged from Froedtert Hospital after a month-long stay and 10 hours of surgery (in addition to the 33 hours of surgery I had earlier). I am now living in the Skilled Nursing Facility at Saint John's on the Lake. Part of my treatment here involves 13 hours of IV nutrition every day. That IV lasts until 8:30 or so every morning, which makes it practically impossible for me to attend the ZND hearing at 9:00.

Even if I were able to attend the hearing, I don't have any expert testimony to provide in support of my nomination. I am only an historic preservation "buff" and not an expert by any means. I can only offer my observation/opinion that the four buildings in the proposed district are quite old, very attractive, in very good condition, and deserving to be preserved.

I hope that my statement above will suffice in lieu of me being present at the hearing to verbally present the same thoughts. I think that this proposed district is an important one, and I hope that my medical issues don't interfere with its approval. If there is anything else that I should do in connection with this hearing, please let me know.
