This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 12/28/22 at 1:54a.m., Milwaukee Police conducted a License Premise Check at 2230 N. Martin Luther King Jr Dr. Officers observed thick smoke throughout the location and a strong smell of marijuana. Further observations included paper rolling packaging, dry leafy substance on tables, partially smoked cigar containing dry leafy substance, and stem of a marijuana flower. The security guard stated they were the only armed security guard at the location and 4 other guards unarmed working under them. The officers on previous dates have observed numerous armed security guards at the location with both semi-automatic and rifles with high quantity ammunition at the location. The green leafy substance tested positive for THC and placed on Inventory.
- 2. On 04/16/23 at 1:28a.m., Milwaukee Police were dispatched to a Shots Fired at 2230 N. Martin Luther King Jr Dr. On arrival officers observed multiple subjects exit the location, as well as several other subject attempting to go back in to obtain personal items left behind. The agent was on scene and was pleasant and cooperative with the officers allowing them to view video surveillance of the incident. The video did not depict where the shots fired came from, however, multiple subjects could be seen looking to the S/E corner of the premise and quickly run into the establishment. The video also showed a subject enter the establishment with a firearm as well as multiple subjects in the parking lot, holding firearms.

3. On 09/23/23 at 11:50p.m., Milwaukee Police were dispatched to a Trouble with Subject at 2230 N. Martin Luther King Jr Dr. Officers were advised that Transit Dispatch called regarding vehicles parked at the bus stop and a subject being aggressive with the driver. On arrival officers observed vehicles parked in the bus stop and a line of individuals attempting to enter the establishment, as well as several armed security guards, who were searching individuals. Officers interviewed a security guard, who stated they would move the vehicles. The officers then interviewed a manager who initially stated "oh you assumed that the individuals who parked their vehicles in the bus zone are inside". The officers explained to the manager that security guards were the one's parking the vehicles.

Upon arrival as PO BURLO and I entered inside of the location, I detected a very strong odor of burnt marijuana. I observed thick smoke throughout the inside of the location. As I looked on the table next to where patrons were seated or would have been seated, I observed tobacco wrapper packaging as well as "PAW" rolling paper packaging. Based on my training and experience as a Milwaukee Police Officer, the contents of this packaging are used to roll marijuana cigars in order to smoke marijuana. I observed the tobacco which is typically inside of the original packaging scattered on the tables and floor of the location near the seated areas throughout the inside of the tavern. As I looked on tables, I observed a dried green leafy substance suspected to be marijuana. Near the Disk Jockey booth, I observed a smoke suspected marijuana cigar. I opened the cigar and observed a dried green leafy substance suspected to be marijuana. As I looked on the tables, the location made the decision to shut down the tavern and have their staff clean off the tables as I observed the stem of a marijuana flower on one of the tables. I then collected from an additional table a dried green leafy substance suspected to be marijuana located next to "raw" rolling paper packaging.

PO BURLO tested the dried green leafy substance suspected to be marijuana using Nark II 05 test pouch. The substance tested positive for marijuana (THC) with a total weight of .48 grams. PO BURLO placed the marijuana (THC) on Milwaukee Police Department Inventory #22046883.

It should be noted that PO BURLO and I, came to this location regarding New Year's Eve event plans on Saturday, December 24th, 2022. On this date, PO BURLO and I were able to detect a strong odor of burnt marijuana as well as observed an extremely thick cloud of smoke inside of the location. PO BURLO warned event host/head of security who was identified as James PERRY (M/B, DOB 11/27/1975) that there should be absolutely no smoking of marijuana inside of the location and that officers would be making frequent visits regarding. PERRY acknowledged the marijuana smoke and stated, "the smoke is beginning to mess with my health" and that officers are "right" in regard to his patrons' smoking marijuana. On the listed date, multiple squads (Squad 5468, Squad 5428, Squad 5371, Squad 5463, and Squad 5311) responded to the address 2230 N Martin Luther King Jr Dr, for a Shots Fired complaint, at approximately 1:28AM. address is a licensed premise in the City of Milwaukee, named Jewels Caribbean.

Prior to officers' arrival, PO BURLO observed the listed location to be having an event and observed multiple subjects in line outside of the main entrance. We then advised several other officers to increase a presence in the area.

Upon officers responding to the Shots Fired complaint, we arrived on scene and walked around the perimeter of the building checking for any individuals who might have been injured. We also checked the area for any evidence of shots having been fired or any kind of property damage. Upon officers checking the area, there were multiple subjects observed outside of the location exiting the location. We also observed several female subjects outside of the main entrance attempting to enter the building. The female subjects were verbally aggressive with staff at the location, as well as officers. The female subjects were heard asking to enter the building to retrieve property they may have left inside.

Officers then entered the building and immediately began identifying employees. One particular employee, identified as *Terry CAMPBELL (b/f, 02/03/99)* was uncooperative in providing officers with her name. CAMPBELL initially refused to provide PO TERRELL with her name. She ultimately provided her last name and walked away from PO TERRELL as he attempted to obtain the rest of her information. CAMPBELL is a "bottle girl" at the location. Officers did not obtain any further information from her due to her lack of cooperation coupled with the number of subjects inside of the location needing to be identified.

I identified the bartenders working to be *Contessia A AHMED (b/f, 10/17/91)* and *Diamond C SHEAD (b/f, 6/27/93)* both AHMED and SHEAD have valid bartending licenses and provided officers with a copy of their licenses via their phones. AHMED stated she has worked as a bartender at the location for approximately two (2) years and only works one day per week (Saturdays) from 10:00PM- 2:30AM.

I spoke with and identified a bottle girl/ waitress, *Natasha J LOVE* (*b/f*, *12/21/91*) who stated she has worked at the location for approximately one (1) year. She indicated her hours to be from 9:00PM to bar close (approximately 2:30AM). I observed another staff member and identified him as *Alexander L HOOLINAN* (*b/m*, *8/2/00*). HOOLINAN stated he has worked at the location for approximately six (6) months and works 10:00PM to 2:00AM. He stated he completes various tasks at the location, I observed him to be sweeping floors when I made contact with him. Another bottle girl was identified to be *Danna M MELTON* (*b/f*, *12/10/01*) who stated she has worked as a bottle girl/ waitress at the location for one (1) year.

PO WELCH identified a male subject working at the location to be a **Jerome TAYLOR** (b/m, 8/28/81), he was believed to be security at the location however he was uncooperative with officers' investigation when spoken to. PO WELCH identified the two other subjects who also appeared to be working as security at the location. They were identified as **Deon J PERRY** (b/m, 1/27/00), and **Satayya A NEVELS** (b/f, 4/10/01).

PO TERRELL spoke with and identified *Thomas PASCAL (b/m, 7/9/66)* who works at the location assisting with maintenance upkeep and is also a cook there. PO TERRELL identified *Gerald M PFEIFER (2/25/57)*

who stated he is a family friend of JULES' and assists with cleaning up around the building. He stated he does not work at the location often and merely assist here and there.

Once all employees had been identified, PO TERRELL spoke with JULES who then assisted PO TERRELL with accessing the surveillance cameras. PO TERRELL and other responding officers began reviewing the surveillance footage. Upon viewing surveillance footage, officers were unable to view who discharged a firearm. Officers did observe multiple subjects standing in front of the front entrance door look to the S/E corner of the premise when shots were fired and quickly run inside of the location. Officers observed a subject enter the location with a firearm in his hand. Officers observed multiple subjects holding firearms who were standing in the parking lot running to the rear of the building and inside of their vehicle.

I asked to view the businesses licenses. JULES provided me with the licenses which were located inside of a locked closet between the front bar and rear kitchen areas. I observed the valid Class B Tavern License (0210679) and related licenses Public Entertainment & Premise License (008541) which are set to expire on 11/5/23. I observed the Cigarette and Tobacco License (1031434) which will expire 9/26/23 and the Food Dealer License (0018198) which will expire 11/17/23. The listed agent was observed to be JULES. As stated, she was on scene and notified of the overall check due to officers dispatched assignment. She was pleasant and cooperative throughout the entirety of our investigation.

Upon my completing my licensing documentation all squads then left the location.

On Saturday September 23rd, 2023 at approximately 11:50pm (While in full duty uniform equipped with an Axon Body Worn Camera activated and in a marked Squad) (P.O Mark WOOD and I) were dispatched to a call for service at 2230 North Martin Luther King Jr. Drive, located in the City and County of Milwaukee for a trouble with subject. The caller Milwaukee County Transit System Dispatch 5 (414-937-3277, located at 1942 North 17thStreet) stated to the tele-communicator that there were multiple vehicles parked at the bus stop, night club and they put cones out, so the bus could not stop at their stop and was being aggressive with the bus driver.

#### **Initial Observations**

During the preliminary investigation for the trouble with subject I did not observe any violations in the licensed premise. Per the district community partnership unit this location is a designated nuisance premise.
