

Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the September 21, 2004 meeting of the Milwaukee Common Council, the essence of which is as follows:

Substitute ordinance approving the change in zoning from a General Planned Development (GPD) to a De-tailed Planned Development (DPD)

Planned Development (OFD) to a Detailed Planned Development (DPD) known as Palermo's Pizza, located on the North Side of West Maple Street between South 8th and South 9th Streets, in the 12th Aldermanic District.

The Mayor and Common Council of the City of Milwaukee ("Common Council") do ordain as follows:

Part I There is added to the Milwaukee Code of Ordinances ("Code") a new section to read as follows:

Section 295-907(2)(b).0061.

(I) In accordance with the provisions of Section 295-907(2) of the Code relating to the procedures and establishment of planned development districts, the Common Council approves the subject Detailed Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set and made a part as though fully set

forth herein.

(2) The zoning map is amended to change the zoning for the area bounded and described by Lots 16 through 30 inclusive and the vacated alley lying between said Lots 20 and 21, all in Block 4, Mitchell's Subdivision, located in the Northwest 1/4 of Section 5, Town 06 North, Range 22 East, City of Milwaukee, Milwaukee County, Wisconsin.

(3) The requirements set forth in said detailed plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described provided further that rained in such planned development district described, provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed plan.

Part 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a sentence distinct and indedeemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions. The Common Council declares that it would have passed this ordinance and each section, subsection, sentence, clause, phrase or portion irrespective of the fact that any one or more sections, subsections, sentences, clauses or above the section of the sect clauses or phrases or other portions be declared void or invalid.
