Dear Mr. Owczarski:

In an effort to maintain proper position authority for grant funded positions in the 2006 Positions Ordinance, the Health Department is submitting this communication relative to technical corrections to the 2006 Positions Ordinance. The first change is related to the approval to allow several more positions to charge the Lead Outreach Grant in order to spend down unexpended salary dollars due to vacant positions and the other changes are inadvertent errors made to corrections to footnotes in three grants at the time of the Grant Resolution. The 2006 Positions Ordinance would need to be amended as follows:

CHANGE Footnote (EEE) to read as follows:

To expire 12/31/06 unless the Lead Outreach Grant is extended. Partially funds the Lead Hazard Prevention Manager, 3 positions of Lead Risk Assessor II, Chemist II, Lab Assistant II, Health Services Assistant II and Program Assistant II.

CHANGE Footnote (C) to read as follows:

To expire 12/31/06 unless the Women, Infants and Children's Grant, available from the Wisconsin Department of Health and Family Services, is extended.

CHANGE Footnote (L) to read as follows:

To expire 7/31/07 unless the HIV Women's Project Grant, available from the Medical College of Wisconsin is extended.

CHANGE Footnote (CC) to read as follows:

To expire 7/31/07 unless the Covering Kids Grant is extended. Partially funds Health Interpreter Aide position.
