I, Gary D. Schneider, Registered Land Surveyor No. 1297, hereby state the following:

That this document is written to make the following corrections to pages 2 and 3 of Certified Survey Map No. 7981 as recorded October 8, 2007, as Document No. 09505406.

That CSM No. 7981 was signed and sealed by Charles A. Formoc, former employee of Kapur & Associates, Inc.

That I have been tasked to create this Affidavit of Correction for the City of Milwaukee in Charles A. Formoc 's absence as follows.

Page 2: That the Surveyor's Certificate reads "... That I have made such survey, land division and map by the direction of the Redevelopment Authority of the City of Milwaukee ...". When in fact, it should read "... That I have made such survey, land division and map by the direction of the City of Milwaukee..."

Page 3: That the Corporate Owners Certificate reads "The Redevelopment Authority of the City of Milwaukee, a Corporation..." when, in fact, it should read, "The City of Milwaukee, a corporation..."

The City of Milwaukee, a corporation duly organized and existing under and by virtue of the laws of the State of Wisconsin, as owner, certifies that said corporation caused the land described on this map to be surveyed, divided, mapped and dedicated as represented on this map in accordance with the requirements of Chapter 119 of the Milwaukee Code of Ordinances.

In consideration of the approval of the map by the Common Council and in accordance with Chapter 119 of the Milwaukee Code, the undersigned agrees:

- a. That all utility lines to provide electric power and telephone services and cable television or communications systems lines or cables to all lots in the certified survey map shall be installed underground in easements provided there for, where feasible.
- b. That direct vehicular access, from all of Lot 1 to N. 23rd Street & W. Lloyd Street and from the west 11.58 feet of Lot 2 to W. Lloyd Street is prohibited as delineated on the attached map.

This agreement shall be binding on the undersigned and assigns.

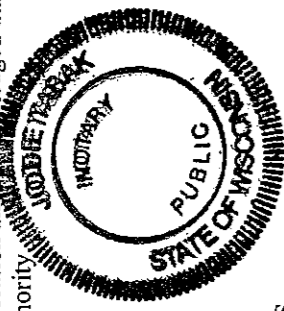

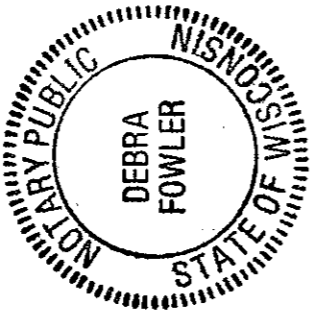
