NOTICE OF PUBLIC HEARING

PLEASE NOTE: This hearing relates to the property that is marked as “subject site” as shown on the map on the reverse side of this notice. If your property is not located at 3804 S. 27th Street, then you are receiving this notice because you are a property owner within 200 feet of the subject site, as required by State Statute.

DEAR PERSON OF INTEREST:

The City Plan Commission (CPC) will hold a public hearing regarding a proposal to utilize the existing building and parking lot located at 3804 South 27th Street as a light motor vehicle sales facility. This site is within the S. 27th/Howard Development Incentive Zone (DIZ) overlay, in the 13th Aldermanic District. The S. 27th/Howard DIZ was created in 2010 for the properties shown on the back of this notice, and establishes permitted and prohibited uses, as well as design standards for developments within the overlay zone. A light motor vehicle sales facility is permitted within the overlay zone, but is subject to a public hearing and approval by CPC.

This site is currently owned by Giuffre IV, LLC and was previously occupied by American Freight & Mattress. Car City Auto Sales, which previously occupied this site approximately 14 years ago, wishes to return to the site and operate an auto dealership within the existing building and parking lot. In addition to the use approval, the DIZ overlay also requires that landscaping is added on the west side of the site, along Wilson Creek. Other site improvements will be implemented, including but not limited to perimeter landscaping and a pedestrian connection along S. 27th Street. **Please refer to the reverse side of this notice for map details.**
