This License Premise Report is written by P.O. Jason JANOTTA, assigned to District 4, Early Power.

On 05/3/2023, at approximately 12:06PM, Squad 4227 (P.O. JANOTTA, and P.O. Christopher JONES, responded to an **Armed Robbery** call, at 6000 W Silver Spring Dr., which is in the city and County of Milwaukee.

Upon arrival, we spoke with Store Manager of Family Dollar, Ronald L BUTLER (b/m, 05/24/84), who stated on 05/03/2023 at approximately 11:55AM, a suspect brandished a black semi-auto glock pistol at him, after approaching 2 female suspect regarding them stealing.

BUTLER stated he was in the cleaning supply aisle, observing the suspects stealing when he approached. BUTLER stated immediately upon him approaching that the suspect pulled out a black Glock pistol and pointed it at him, saying "You aint gonna do shit".

Upon arrival the store security agent inform police that he was not at the store at the time of incident and just returned from lunch.

Family Dollar did provided initial video of the suspects involved and waxs cooperative with the investigation.

BUTLER provided the Certificate of Occupancy, issued to "Family Dollar Stores of Wisconsin LLC" which was issued on 9/25/17 (# NOCC-17-01637)

This report is written by P.O. CATANZARO assigned to District 4 early shift. On Tuesday May 9th, 2023, in full duty uniform, in a marked squad, and with an Axon 3 body worn camera activated I responded to 6000 W Silver Spring Dr for a subject with gun complaint.

This location is a Family Dollar grocery store.

upon arrival officers spoke with manager Ronald BUTLER (M/B 05/24/1984 5739 N 72nd St Milwaukee WI) who stated he recognized a known shop lifer enter the store in a wheelchair. this suspect is described as a black male, 50-60 years old, wearing green pants, black shirt, brown dress shoes, wearing glasses, with a large gray afro. The wheelchair has a dark canvass seat, with a bright blue pad on the backrest.

The suspect entered the store with sitting in the wheelchair, then can be seen standing up and taking merchandise and hiding it on the seat of the wheelchair and in a red bag on the back of the chair. BUTLER then asked the man to leave, and he displayed a handgun and stated, "I got something for you." BUTLER stated the suspect was holding a small frame black handgun, never pointing it at him, and then put in down his pants. BUTLER stated the suspect then began to yell "come outside and see!" The suspect then left the store and went to a bus stop on 60th and silver Spring Dr, then crossed the street, and went into the closest Westbound alley, Northeast of Silver Spring Dr, and entered silver or gray Chevrolet SUV, possibly an equinox, unknown plate and left the area.

BUTLER stated this person took laundry soap and other household goods valued at about \$50.00.

BUTLER stated he used to work at Dollar General at 1300 E Locust St and has seen this person shop lifting at that location. Officers located many IR reports, one with an unknown actor in a wheelchair, but no names were obtained.

This incident was captured on security cameras. BUTLER provided a manager card, for Amy BRUNETTE, AP MARKET INV ESTIGATOR, 500V olvo PKY ChesapeakeV A 23320 262-705-4965, abrunet4@familydollar.com.

Officers will send a evidence.com link for the video footage to be recovered.

Officers captured the best still image from the camera footage and have attached it to this report.

Officers contacted Fusion Dept. who stated they do not have a blurry image at 4:52 of a figure with a wheelchair, but the video is of poor quality.

On Monday, May 21st, 2023, at approximately 8:12 PM, I was dispatched to Family Dollar LLC at 6000 W Silver Spring Dr, located in the City and County of Milwaukee, Wisconsin for a THEFT complaint.

Upon my arrival, I observed Family Dollar which is a food retailer was still open for business, and several customers exiting and entering the business.

I observed the Caller/Manager Ronald L BUTLER (b/m 05-24-1984, ph #414-317-3827) standing outside the entrance of Family Dollar. I spoke to BUTLER who stated an unknown b/f mid 20's, wearing gray clothing, who has stolen merchandise in the past came into the store and appeared to be attempting to steal again.

BUTLER then stated while observing the unknown b/f, he informed her that he recognized her from previous encounters and that she was no longer welcome inside the store. BUTLER stated after informing the b/f that she would have to leave the store due to past theft complaint against her. BUTLER stated the b/f refused to leave the store which prompted BUTLER to call the police.

BUTLER stated after informing the female that he was going to call the police, the b/f picked up an item and went to the nearest cash register, paid for the item, and left the store. BUTLER stated he attempted to cancel the call but was unable to due to the officer's quick response. BUTLER stated police services were no longer needed and the b/f was no longer on scene.

While on the scene, I observed the licenses posted and they were up to date. During my investigation for Theft, I did not observe any violations in the licensed premise.

Upon my arrival I observed the parking lot of the establishment to have multiple unoccupied vehicles parked. I also observed multiple citizens standing near the corner of the N 60th St and W Silver Spring Dr. On this scene MPD had multiple squads respond due to the nature of the incident as well as a Detective response.

I observed multiple spent casings located in front of the premise. I also observed the front door of the premise to have multiple gunshot strikes.

I was not able to speak with the original caller due to no answer from original number. It is unclear if any of the callers are employees at the location.

I attempted to speak with a possible witness who was attempting to leave the scene after my arrival on scene. This individual would later be identified as Jazmin M PERKINS (B/F 09-21-2000), who is a manager at the location. PERKINS would later be arrested for obstructing a police investigation.

I spoke to licensed premise manager who later arrived on scene. They stated that they were not on scene during the incident. The business and its employees were cooperative during the investigation. Employees stated that they were unable to call due to the incident occurring and fear due to the nature of the incident.

The business did have camera footage and agreed to provide the footage to law enforcement. The business did have 1 (one) security guard on duty on the night of the incident. This armed security guard however was 1 (one) of the suspects in this incident and was responsible for discharging their firearm at the victim in this incident.

Quincy D PHIFER (M/B 11/11/1996) was identified as one of the two suspects in this incident. PHIFER was working as a security guard at this location during the incident. PHIFER was also a victim in this incident where he was shot in the lower buttocks. PHIFER was also stated to have discharged a firearm, striking Andre L FRANKLIN (M/B 10/01/1999). FRANKLIN was both a suspect and victim in the incident. FRANKLIN was an employee at the location and was shot by PHIFER in his left arm. FRANKLIN was also said to have been armed with a firearm and was said to have discharged his firearm striking PHIFER.

I did not personally review the video surveillance footage. The footage was reviewed by P.O. WEST. This video shows two subjects in a verbal altercation which turned physical. This altercation later led to the discharging of firearms leading to the shooting.


