This office is in receipt of your claim in the amount of \$863.28, relating to damage sustained to your vehicle on February 5, 2001 when a City sanitation crew allegedly scratched is during garbage pick-up at 2403 North 56<sup>th</sup> Street.

The Sanitation Division records indicate the Sanitation crew assigned to this location denies causing said damage to your vehicle.
