This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/30/16 at 5:18 am, Milwaukee police were dispatched to 405 N 27th Street for a strong arm robbery complaint. Officers spoke to the caller who stated he drove to the BP gas station to "buy candy". While at the gas station, he was approached by a homeless looking man in front of the store and showed the caller some weed. Both subjects then went to a car that was parked behind the caller's auto at the gas pump. Inside that car was three males and the caller got into the car with and they drove into an alley where they forced the caller out of the car and demanded the caller's property. Obtained were cash and a Samsung Galaxy S7 cell phone. The caller then returned to the station where he called for police. He was later arrested for loitering drug related and processed at D3. This case is pending.

2. On 01/07/17 at 5:50 pm, Milwaukee police observed a known subject aggressively panhandling in front of 405 N 27th Street. Officers asked this subject to leave and briefly did, but upon seeing the squad car leave the area, returned to the location and was seen approaching autos and asking for money. The subject was arrested and cited.

3. On 01/10/18 at 11:27 pm, Milwaukee police was dispatched to 405 N 27th Street for a Man with Gun complaint. Officers spoke with Loyd Milton, who stated he was a security guard working for the gas station. Milton stated he was having trouble with a subject who was selling shoes in the parking lot of the gas station. Milton stated this was an ongoing problem and that this subject has caused problems at the business before. Milton stated he asked the subject to leave and he refused and started walking towards Milton. Milton stated he feared the subject was going to do something so he pulled out his pepper spray and attempted to spray the subject. Milton stated the subject then fled on foot. Police checked the area for the subject, but could not locate him.

- 4. On 01/20/18 at 4:18pm, Milwaukee Police performed a field interview of a subject who was panhandling outside of 405 N. 27th street. The subject was advised not to panhandle and to leave the property. The subject left the property.
- 5. On 01/23/18 at 6:18am, Milwaukee Police were dispatched to 405 N. 27th Street for a trouble with subject complaint. Upon arrival, officers called the caller who stated the subject left the establishment. The area was check for the subject but no one was located.
- 6. On 01/23/18 at 7:04pm, a Milwaukee Police Officer observed a subject at 405 N. 27th Street who had geographical restrictions and should not be in the area. The subject was stopped and arrested for open warrants and bail jumping.

- 10. On 08/11/18 at 12:46pm, Milwaukee Police were dispatched to 405 N. 27th street for a panhandling complaint. Once officers arrived, the subject was no longer at the location.

13. On 07/27/2019 at 1:15am officers were dispatched to an overdose at the BP gas station at 405 N. 27th St. The officer found MFD with a male subject unconscious in the bathroom. The subject was revived with Narcan and stated he came to the area to get pills from a friend. He then went in the bathroom and snorted the pills. The subject was arrested for violating his probation.
14. On 09/23/2019 at 9:11pm officers were dispatched to the BP gas station at 405 N. 27th St for a Property Damage complaint. The clerk stated an unknown subject was stealing items from the store so he locked the door to prevent the subject from leaving. The subject then used thongs from a display to pry open the door to escape. The subject fled on foot.
15. On 09/27/2019 at 12:51am officers were dispatched to a Trouble with Subject at 405 N. 27th St. A female was panhandling at the station and refused to leave when asked. The subject was taken into custody on an unrelated charge.
16. On 10/11/2019 at 9:48pm officers were flagged down for a Theft complaint at 405 N. 27th St. The subject wanted to report a Theft that occurred several days prior at a different location. The business was not related to the complaint.
17. On 10/18/2019 at 4:06am officers were dispatched to a Subject with Weapon at 405 N. 27th St. The investigation revealed the victim picked up the suspect on the southside and was driving north on the viaduct when the suspect took the victim's wallet and exited the auto. The suspect then entered the business and went in the bathroom. The business was cooperative with the investigation and allowed officers to observe the video surveillance. The subject was issued a theft citation.
18. On 10/27/2019 at 11:39am officers were dispatched to a Dead on Entry complaint at 405 N. 27th St. The officer found MFD on scene with a deceased person inside the gas station near the front counter. The clerk stated the subject was at the counter having trouble breathing so he called 911. MFD stated the subject appeared to died due to cardiac arrest and nothing appeared suspicious. The officers were able to view video surveillance of the incident.

19. On 09/19/2020 officers were dispatched to a subject with weapon at 405 N. 27th St. The caller stated a subject was breaking out the windows. When the officers arrived the clerk stated the subject left and nothing was broken.

24. On 11/05/2020 at 11:59pm officers were dispatched to a Trouble with Subject at 405 N. 27th St. The call stated a subject was causing problems and wanted him removed from the property. The subject was gone prior to the officer's arrival.

The officers spoke with the clerk who stated he did not observe anyone with a gun. The caller was taken for medical treatment.

The business was cooperative with the ongoing investigation.

Police spoke with the caller who stated she gave money to the store clerk for gas at pump #15. When the caller attempted to pump gas, it would not dispense. The caller stated she was hit by the employee during the argument over the gas. Police then

spoke the manager who stated that the caller requested gas at pump#1 and pump #1 was used by another vehicle. The manager stated that the caller was trying to scam the gas station, and refused to refund the caller. The manager stated the caller then became irate and poured gas on the floor in attempt to ignite it. Police reviewed video and it was evident that the caller parked at pump#15 and time pass before the caller speaks with the manager. On the video the caller is observed pouring diesel fuel on the floor but did not attempt to light the fuel. Police cited the caller regarding the incident.

Officers were advised a suspect broke two exterior windows of the property using a block of concrete. On 08/31/23 at 12:29p.m., Milwaukee Police were dispatched to an Entry to Auto at 405 N. 27th St. Investigation revealed a suspect took a purse out of the victim's unlocked vehicle while they were inside. On 11/15/23 at 11:47p.m., Milwaukee Police were dispatched to a Subject with Gun at 405 N. 27th St. Investigation revealed suspect 1 stood by the door with their hands concealed while the suspect 2 began to take items off the shelf. Suspect 1 tells the cashier "step back or I'll shoot you" and points a firearm at the cashier. Both suspects then fled the store. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

On Friday, April 21, 2023, at 1:45am I responded to a report of theft at 405 N 27th St. I was in full MPD uniform with a functioning Axion BWC. The caller stated that a pressure washer had been stolen from the location.

When I arrived, I spoke to Jaideep SHARMA. He stated that in addition to a pressure washer being stolen on 4/19/23 (IR 23-111-0015) his coworker had been robbed at about 11:00pm on 4/20/23 (23-111-0016) but it had not been reported yet. SHARMA was cooperative throughout the investigation, and they provided high quality video.

Synopsis from police report filed by detectives:

Interview of Victim (Manjeet NMI SINGH m/w 12-10-95)

I spoke to SINGH, inside of the gas station, in the area where employees sit, behind the counter. SINGH Primary Language is Punjabi (Indian). Another Employee (Jaideep NMI SHARMA m/w 06-08-93) came to the location, after the incident happened. SHARMA was more fluent in English and translated for SINGH, while I interviewed SINGH regarding this incident.

SINGH stated that he was an Employee at the BP Gas Station, located at 405 N 27th St. SINGH stated that he was working, at approximately 10:47pm on 04-20-23, which was the time of the incident. SINGH stated two Suspect(s) came into the location. SINGH described the Suspects as:

Suspect #1

B/M, 30's, 5'10", 200 lbs., dark complexion, heavy build, Durag, wearing all black (black hooded sweatshirt with hood/ black pants/ black shoes), clean shaven

Suspect #2

B/M, 23-24 years-old, 5'05", 250 lbs., dark complexion, heavy build, wearing all black hooded sweatshirt, tan cargo type shorts, red shoes

SINGH stated initially, Suspect #1, bought a Black and Mild Cigar and Flat Wraps. SINGH stated the amount of those items were approximately \$3.00 and Suspect #1 paid using US Currency. SINGH stated then, Suspect #1 then grabbed a box of merchandise, which contained Slim Jims (Whole Box) (25 total in box) (\$3.99 a piece/ total- \$99.75) Slim Jim Snack Size (Whole Box) (120 total in box) (\$.50 a piece/ total- \$60.00). Total amount of merchandise according to SINGH was \$159.75. SINGH stated that Suspect #1 then attempted to exit the business, along with Suspect #2, not paying for the merchandise and he locked the door preventing the suspects from leaving. SINGH stated that Suspect #1 then stated, "Open the Door, or I'm going to shoot it!"

SINGH stated he then saw the handle of a black in color hand gun, protruding from the left pocket of the hooded sweatshirt Suspect #1 was wearing. SINGH stated that Suspect #1 then set the box of merchandise down on the counter and he (SINGH) unlocked the door. That another customer the walked in, both Suspects went by door to exit, then Suspect #1 walked back up by the counter, grabbed the box of merchandise and both suspects fled out of the business.

SINGH stated that he did not call the Police initially, because he has a hard time communicating in English.

SINGH stated that whole incident made him fear for his safety and it was done intentionally and without his consent.

Video review:

At approximately 00:03, both Suspects can be seen, walking from the south (W St Paul Ave), past the gas pumps, towards the main entrance of the gas station.

At approximately 00:45, both Suspects can be seen entering the main entrance of the gas station.

At approximately 06:45, both Suspects can be seen exiting the main entrance of the gas station and walking east on the walkway, alongside the front of the gas station. Suspect #1, is seen talking merchandise out of the box he is carrying and throwing it on the walkway. Suspect #1 then overturns the box of all remaining merchandise. Suspect 1 and 2 then pick up some of the merchandise and walk off eastbound from the location. Then other people, that were at the gas station pick up the merchandise and leave.

Immediately, both Suspects are standing by the counter of the gas station and Suspect #1 is communicating with the Victim.

At approximately 01:25, both Suspects walk away from the counter.

Then suspect one began to pull items from the counter area and the front-end caps holding them in his hands.
