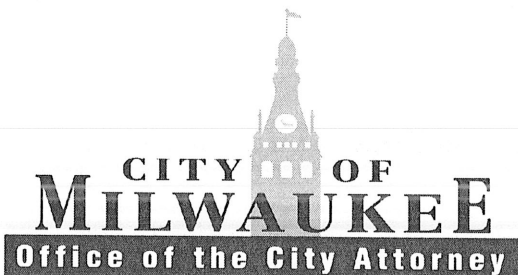

Dear Sir or Madam:

Chris Sendelbach, with his insurance company Badger Mutual Insurance, submitted a claim for property damage sustained from a water meter exchange on June 10, 2024, located at 3240 N. 80th Street. Badger Mutual Insurance is seeking their subrogated interest for mitigation repairs in the amount of \$14,191.04.

We have completed an investigation of this matter with Milwaukee Water Works. Our investigation revealed that damage was likely a result of MWWs' repair activity when the inlet coupling broke while operating the Ground Key Stop valve and caused water to flow into the basement of the property. A supervisor responded to the property to aid in water shut off.

Badger Mutual has agreed to a settlement amount of \$14,191.04, and we recommend that the claim be approved for payment.
