

I begged and pleaded they asked me to leave and I could retrieve it on Monday, June 7, 2004.

I went to the tow lot on that day and was told to inspect my car. In that my seat on the drivers side was cut about an 1 inch 1/2. I was told to look through my car thoroughly. It was a mess from the police conducting their search.

My husband is a meat cutter for a BBQ business locally (Speed Queen BBQ/ Kings of BBQ (Racine business)) his knife is gone. He also stated to me he had his wedding ring in the middle console below the radio that is gone, (that is worth \$1500.00) I had a pair of diamond hoop earrings (worth \$450) they are gone. These were all very precious to us. Tapes and Cd's were damaged as well. After I drove off I noticed my alignment is totally off it was not before I am assuming that is from the tow.
